### 9. NEW CORPORATE BUSINESS

A. 2017-2018 Associated Student's Operating Budget (1<sup>st</sup> Reading)

Haller summarized the proposed ASI operating budget for next academic year.

The \$2 increase in student fees will be effective beginning in the Summer 2017 semester.

Projected Budget for ASI for next academic year is: \$4,782,965.

Preliminary Allocation is the amount that is amount assigned to each department; then the departments look that over and submit requests to Haller for the amount needed to run that department.

Haller would like to allocate \$5,000 to fund scholarships for each, undocumented and international students.

The Recycling Center no longer requires a subsidy from ASI fees.

Some of the proposed department allocations are as follows:

• Student Organizations Grants: \$250,000

College Council: \$250,000

• Club Sports: \$238,190

At-Large Organizations: \$145,000Student Emergency Fund: \$10,000

• ASI Scholarships: \$25,000

• EOP (Educational Opportunities Program) Book Grants: \$40,000

Haller pointed out that this is the first reading and asked members of the board to look the proposed budget over in detail and to submit any amendments before final approval.
