VP Vournas spoke to the board regarding a potential proposition to move ASI funds from Wells Fargo and into a credit union and pointed out that Wells Fargo is a company that heavily contributes to some controversial issues like the prison system and the Dakota Access Pipeline.

Sen. Gomez asked how this would work with the Wells Fargo location that we have on campus and how this process would work and how long it would take. Haller pointed out that Wells Fargo does have a lease on campus until 2028.

Haller also explained that if this were something that the board would like to pursue, they would have to prepare and issue a Request for Proposals (RFP), allow the banks time to respond, form a committee to review the responses, come up with criteria for evaluation, etc. So it would be something that takes a few months before it is actually goes into effect. The next step would be to add this to the agenda as an action item.
