Section One: Addressing Prompt

- How well does this student support their need for the scholarship with examples of other factors (other than financial need)?
- How extraordinary were this student's circumstances?
- How well does the student's story appeal to your emotions?

Section Two: Financial Need

- How much financial assistance has this student expressed?
- How much will this scholarship financially benefit this student?
- How much financial struggle has this student been facing?

Section Three: Other

- How deserving is this student of this scholarship?
- How well did the student explain what winning the award will mean to them?
- Based on their words, how will this scholarship affect their ability to succeed at CSULB?

Section Four: Academics

Award points on the following scale:

- 2.50-2.74 0 pts.
- 2.75-2.99 1 pt.
- 3.00-3.24 2 pts.
- 3.25-3.49 3 pts.
- 3.50-3.74 4 pts.
- 3.75-4.00 5 pts.

Section Five: Overall

• The focus of this section is to strengthen an application's point total based on its overall impact on you as the selection committee member. Remember to be very conservative as you assign points for this section to ensure that only truly deserving applicants receive higher points.

On a scale of 1-10, give an overall score for this application.
