8. NEW BUSINESS

A. Action Item: Approval of the Policy on Student Government Scholarships

(M) Velasquez (S) Galindo to approve the Policy on Student Government Scholarships with the recommended changes

Chiu: Consider making changes for 2.0 eligibility, reducing the minimum units for grads student should take (30 units); Proposing a discussion on change of unit loads

Villegas: Came to an understanding with what Chiu said about maintaining the standards

Richardson: In favor for both undergrad and grad students to have 6 units as per equity point-of-view

Roy: This board is talking about need-based scholarship and not merit-based scholarship; Therefore, GPA requirement won't have to be that necessary.

Richardson: Found a policy on academic probation – 9.06 "Undergraduates are on academic probation is GPA falls 2.0, while Graduate students are placed on academic probation when cumulative GPA falls below 3.0"

Chiu: Table of contents having issues on number of course loads – needs editing to avoid misperceptions; For Who Should Know About this Policy section, they are wondering if can include grant recipient

B. Discussion Item: Student Life and Development (SLD) Feedback
Villegas: These are itemized feedbacks when they met with Celia and Camacho, and highlighted the 15% reserve
policy; Would like to remove this 15% policy so current college counsels can access the accounts put on reserve

Galindo: Asked clarifications for the 15% policy

Villegas: Issue with college counsels why we have the 15 % reserve if most of them are already not receiving sufficient funds and no process in place on how to obtain that money

Ware: Last year, there were college counsel groups requesting money to BOC; And there were a lot of groups who did not spend money, money was available, but they weren't able to access it for it already belonged to somebody else; Now, board wanted to set aside 15% as a reserve should anything arise.

Nevin: Asked Ware if they can bring an accounting paperwork of all the counsels so we can proceed with a well-informed decision; Health and Human services got somewhere \$25000 of allocation last year and 15% of that is roughly around \$2500

Villegas: This is under discussion right now because they get a lot of question RE the reserve; They weren't here last semester so just wanted to have clarification in any case someone asks for it; Then and only then, they can offer a well-informed response; Will wait for the paperwork from Ware.

C. Discussion Item: Sign Language Interpreter Services for Student Organizations Villegas: Camacho requested this as a discussion item; however, they are not at today's meeting.

Richardson: Representatives came to ask for services back when they were working at College of Liberal Arts; There's a particular need for a support to the interpretation services

Villegas: They like the idea of including this particular community (interpretation services) in their application

9. REPORTS

A. Treasurer

Villegas: Financial Literacy workshop; pre-planning on the next one – Wells Fargo event on Oct 17th; Implementing Program Evaluation Assessment, form that student orgs need to turn in by students.

B. Senate Representative

Galindo: Two items for legislative business, they approved 2020 03 in support of California Assembly 48 which will be in ballot for 2020 Election, 50-Billion-dollar bond, sub-section of this bond will support California Universities; Approval for 2020 04 for policy agenda at this year's senate; Marching 100 days and 100 classes.

C. Executive Director

Ware: Talked about the allocation for the college counsels; Chair Villegas is correct in each of the colleges with percentages being withheld - \$20274 in reserve; Will let the board know next week so the board can come up with solutions on how to use this reserve funds.

Nevin: In a month, they will produce a consolidated ASI financial statements for BOC to see where we're at.
