5. ANNOUNCEMENT FROM THE CHAIR

Elasmar announced/discussed the following:

Informed the board that it seems that weekly meetings are not working, so they are thinking of making the meetings biweekly on either Monday or Friday mornings. Based on discussion biweekly Monday mornings at 10 would work best for those present.

Just got the work order approved from ASI Comm regarding the art gallery submissions, but still has not gotten approval from the Program Evaluation Committee to use the art gallery. They are still going to open applications, and if they are not given approval to use the art gallery, they will move the event somewhere else. Elasmar will send final approved materials to the board so they can start advertising.

Is now a part of the Live Your Life Day Committee, so if anyone or knows of an organization that is interested in participating in this, let them know.

Just had the Safety Night Walk last Thursday and it was successful. They will put together a report and distribute their findings to the board as well as those who participated.

Health Safety Fair: April 24th and 25th, from about 10 am to 3 pm to counteract the Genocide Awareness Project (GAP) event that will be held on those days and times to help inform students and be more present than past years. If there are any aspects that members of the board would like to bring to this fair, please share them with Elasmar.

They will also be having educational speakers, representatives from organizations such as Planned Parenthood, and de-stress activities and crafts.

Merino asked if they are going to work with the Women's Gender and Equity Center on this event and if there was a political component to this fair, even though it is considered a health fair.

Elasmar agreed that it is a political topic, so if there is something that they would like to include or change, it can definitely be incorporated. Added that they collaborated with WGEC in the past, so they are open to working with them on it this year. Since Merino is meeting with them today, they could bring it up to them and provide the board with an update at next week's meeting.

San Miguel suggested working with Dr. Piya Bose to do a campus wide announcement to inform as many students as possible about this event.

Nino encouraged the board to help with any efforts or ideas regarding the March for Our Lives event and to keep them posted on all the work they have been doing for their respective communities.

8. UNFINISHED BUSINESS

A. Discussion Item: Conscious Collection Art Gallery

Elasmar received advertising tools for Conscious Collection and will send out all materials later today. Applications for art submissions are due on March 16th. Art does not have to be done by March 16th, but rather around mid-April.

Beach Pride Events is having an event called Beach Diversity Week on the week of April 2nd. It will be a combination of Queer Diversity week and a couple of diverse weeklong events that were centered on different underrepresented communities. This is the first time that they are doing this, so Elasmar is requesting that board members be present at this event so they can provide as much as feedback as possible.

Because Beach Diversity Week falls in line with the theme of the Conscious Collection, Elasmar was thinking they could do the art gallery opening on either April 5th or April 3rd, instead of the 12th as previously discussed.

San Miguel pointed out that if they did the event on April 5th, they would only have a few days for marketing on campus due to it being the week after spring break.

Elasmar agrees and thinks that they could do marketing a little bit earlier than last year and a lot of their marketing was done via email. Pointed out that if they did it on the week of April 2nd, they would have to set up the art gallery during spring break.

Cail would have a scheduling conflict if it were moved to the week of April 2nd, but they feel that it would be a good idea to incorporate it into Diversity Week.

Elasmar will follow up with the board members who are absent today and will keep the board updated on the date

for this event. Reiterated that they would like everyone to attend some of the events during this week, especially those that are related to their specific communities.

B. Discussion Item: Fall 2017 Review – Campus Wide Issues

Elasmar has not received updates from everyone regarding student concerns and issues. Asked all board members to submit their updates via email by Friday, March 2nd so they can discuss that at next week's meeting.

Cail asked what the tone or direction was going to be set at this event. Is it gun violence in general, or are they going to focus more on what LBUSD is doing to address this?

Elasmar stated that LBUSD is going to meet this Wednesday and then there will be a follow up meeting, and Nino did want some board members to attend the follow up. They will keep board members posted on the date for that meeting and encouraged anyone who is able to, to attend.
