- 2. Met with Terri Armstrong to talk about the OUT at Work Panel and Networking Mixer
 - Event focused on the experiences of LGBTQI+ professionals and how to navigate the professional world as a member of the LGBTQI+ community
 - Tentative dates: October 16th or 29th (Tuesdays)
 - Event starts at 5 PM and ends around 7 PM
 - Finalizing the panelists and aiming for around3 or 4 panelists
 - Usually held in the Career Development Center, but looking into other possible venues
- 3. Began emailing the different LGBTQ+ student organizations on campus about the creation of the coalition
 - Queers and Allies, the LGBTQI+ Student Resource Center, Delta Lambda Phi, and Rainbow Cafe
 - Goal is to create a forum for leaders of the organizations to come together and take with one another

J. Women & Gender Equity Affairs

• I met with Pamela Lewis from the Women & Gender Equity Center. Unsure when Pam Rayburn will be back or what events Pam had planned for WGEC, Pamela and I discussed upcoming film series and a series of workshops that we would like to partner on for our students. Dates for these film series are October 24th, the movie is called Papa's Time Machine, a documentary on Alzheimer's and on November 13th is a film about Online Dating. I have to reach out to those in charge of the film series to discuss with them the times of those events.

- Pamela and I will be meeting on Monday the 23rd to discuss a "How-To" series, intended to help students with a platitude of "skillsets" that some students may not have had the access to learning prior to college. Examples include, "How to walk in heels" "How to healthy eating and grocery shopping" "How to change a tire or your oil". I am currently asking students around to see what things they would have wished to know or would like to know to hopefully incorporate these into the series. We also have a few things we want to get started for Black History Month and Women's History Month, however we will discuss those more in depth after we flesh out our "How-to" series.
- I met with Xan to briefly go over the Woman's night at SRWC. The first event will be October 9th, 5-7pm. The event is titled "Girl's Night". Since it is unclear if this is open to those who identify as woman, I asked if this event is only open to Ciswomen or to all woman. Xan said it is intended for all walks of woman, so I believe with the upcoming events they may work on the wording of the name. Dates for November were discussed. November 20th was a potential date since Xan believed there may be an LGBTQIA+ recognition that week? If anyone is able to confirm that for me.
- I met with Title IX this past week as well. There is a peer advocacy training that they would like to start getting started however have been busy with cases. They would like to partner with ASI to create a pool of student leaders who are trained that can help students with any cases regarding Title IX anywhere from bullying to sexual assault on or off campus. I can discuss this further in person. I have handouts that I will be passing out as well to show what Title IX currently has started for their program.
