- Scholarships specific to the community.
- The university and ASI should partner up with outside organizations

- Financial support for PPS in forms of scholarships or other ways, to make an exception.
- Family Friendly Campus. And to make another Family Friendly space like the one in the library.

Women and Gender

- More support for Not Alone at the Beach,
