 - Reach out to admin, faculty, and staff who have worked with previous cabinet members so that we ensure the continuity of programs/projects that have been implemented.
 - > It would be helpful if, in our transition papers, we left a list of contacts for them
 - Attend Senate meetings whenever possible
 - > There's a lot of information given at those meetings that affect our constituents.
 - Reach out to organizations and ask if you can introduce yourselves at one of their meetings.
 - > The sooner the better
 - Doesn't need to be specific to your community because it's likely there will be students from your community in any organization
 - Plan at least one event per semester as a cabinet, one that is not part of Respect Diversity Week. It's important to collaborate with each other. I wish we could have done more of that this year.

Cáceres

Cornelio

- The Biden administration is currently reviewing existing Title IX legislation and has invited public comment. In a letter to US Secretary of Education, Miguel Cardona, we urge the Biden administration to rein in overly broad interpretations of "mandatory reporting" reporting policies that require university faculty and staff to report the names of sexual assault, dating violence, and sexual harassment survivors to campus administrators.
- The Academic Alliance for Survivor Choice in Reporting Policies (<u>http://alliancesurvivorchoice.org/</u>) is a consortium of over 100 academic experts in the field of sexual and dating violence that is asking the Biden administration to:
 - Adopt a discloser-centered reporting policy that removes employee mandatory reporting requirements in cases where the survivor does not want to report to the Title IX Office
 - Mandate trauma-informed training for faculty and staff on how to respond to survivor disclosures of sexual and dating violence (e.g., supportive listening, referrals)
 - Allow survivors to receive supportive measures and accommodations from a variety of sources on campus, not just the Title IX Office (e.g., confidential victim advocacy centers on campus)
 - Ensure that there are clear exceptions in any mandatory reporting policy (e.g., public awareness events, social media posts, academic classes and work products, hiring and admissions process, research study participation, campus climate surveys, assaults that occurred prior to university enrollment or employment)

Flores

- More engagement with students, such as IG takeovers.
- More collaboration with Senators and Justices.

Jones

- Seek collaborations with other commissioners and other student government leaders
- Establish personal relationships with your respective communities very early in your role
- Utilize the advisor for help with anything regarding your role. (i.e. writing resolutions, guidance, connecting with others)
