Grade Appeals

Sat on a grade appeal for the College of Health and Human Services. The decision was made unanimously.

Senate Meeting:

Wednesday, March 9, 2016

- Various members of the public appeared comment in this weeks meeting.
- Dale Lendrum commented on the issue of campus safety. Students will no longer be allowed to smoke on campus, but are allowed to bring a 2-inch knife and is bothered by this.
- Nina from ASI Communications updated the board of upcoming events. Announced our “Legal Aid Services” workshop.
- Susy Cuevas: reported on “How to Manage Police Interactions”; and informed Senate on our upcoming event – Legal Aid Services.
- Karrie Comfort: Announced she does event promotions for Senate, Judiciary, Cabinet, Executive Officers. She is a good point of contact for our promotion needs.
- AVP of Academic Technology Shawna Dark: expressed interest in doing reoccurring presentations with updates for the Senate. Wants to focus on improving Beach board and technology in the class room. Wants us to spread awareness of www.Lynda.com as it is a useful tool to educate student in various topics (word, PPT, excel) and is free for CSULB students.
- Lindsay San Miguel: The round 2 elections filing period for unfilled positions has resulted in 12 new applicants.
- Jose Salazar: Congratulated those who will be running in the elections, and informed all that he is preparing for CHESS and his upcoming trip to DC. He also informed the Senate the Academic Council voted on the Intellectual Property Policy → Faculty Intellectual property rights, will follow up with Senate regarding more information on the policy
- Resolution in support of the 49er Foundation adopting a socially responsible investing Policy was approved with 3 abstentions.
 - There was discussion before the motion to approve regarding the language of the resolution, in particularly the addition to the line of the CSU System to add an example of the UC System’s socially responsive policy.
- Resolution to commend Dream Success Center on One Year Anniversary – motion passed
- Senate passed legislation to add additional Student-at-Large position on Lobby Corps to spread out the work and increase lobbying efforts.
