Both the GAP and these Hellfire preachers are allowed free reign on campus at the cost of student mental health and education. And why do we exist if not to educate? The most recent time both these groups were on campus was during midterms and how many of you can test well after having been assaulted? Or how about when you can hear the yelling about hellfire and brimstone during your test? What about when you're the one being condemned?

What this all leads up to is the fact that these groups are harassing and intimidating students on campus. I would like to quote from Campus Policy:

"The exercise of free speech and assembly rights must comply with all applicable federal, state, and local laws, and may not:.... Harass, intimidate or impede the movement of persons:"

The club which sponsors the GAP, the Catholic Newman Club, does nothing to mitigate the intimidation & harassment that is caused by people who are either a part of the GAP, or come in support of the GAP. If they pursue such a public display of their views, then they should also take responsibility in ensuring that their event does not promote or encourage people to harass and intimidate women on campus. It is simply unacceptable for this kind of action to be allowed. This harassment and intimidation interferes with the education of these women, as well as contributing to a hostile climate that threatens their safety.

In allowing this behavior to continue, CSU Long Beach actually infringes on these women's, these students right to education under the California constitution. The slurs hurled at the women of this campus constitute a hate crime because of the level of harassment and intimidation that is caused by this hate speech. This hate speech infringes on the right to education by causing undue stress, by being acts of intimidation targeted towards women, by threatening their safety, and to draw on Penal Code section 422.6, threatening their "free exercise or enjoyment of any right or privilege secured to him or her by the Constitution or laws of this state." Since the right to education is part of the constitution of California, and since the hate speech threatens the free exercise of this right, the GAP allows for and encourages hate crimes against women, who are being harassed, threatened and have their education put in peril. As an institution of higher learning, and a public university of California, it is part of the responsibilities of this campus to ensure that the right to education is not being infringed.

Up to this point, every step of the way we have been met with sympathy and "sorry, we can't help you". Now you asked us to come here to hear what we are "requesting of this branch" and what we really want is for the GAP, and the Hellfire Brimstone Preachers to get off of our Campus. However we recognize that the University is unwilling to spend the kind of money it would take to actually stand up for student safety in this way, so the rest of our requests shouldn't be too much trouble:

- 1. A campus wide email explaining students rights on campus with a link to an easily accessible webpage regarding said rights.
- Campus police to be up to date on our rights and be able to enforce them. For instance during the two days of the GAP presence campus police were present, ready to defend

Speech at Judiciary Meeting:

I would like to thank you for inviting Safe Space CSU to speak with you here today. In order to provide a "better understanding of this issue and what it is [we] are requesting of this branch" we must first discuss context. To put our organization in context; My colleagues and I started Safe Space CSU because we were tired of seeing the distress that the Genocide Awareness Project and the Damanation Breachers have caused among our classmates. We were tired of talking about how harmful these intruders were without having any action taken against them and we were particularly tired of having to cope all while our school sent out email after email claiming to care about student safety and yet doing nothing to alleviate our pain.

This of course comes on top of the larger context of violence in our society today which plays into why these groups are particularly harmful to our students. This context includes a world in which leading politicians such as Ted Cruz are proudly advertising endorsements by people like Pastor Kevin Swanson who openly advocates for the state murder of homosexuals. In which Donald Trump has become the GOP front-runner by campaigning on a platform of hate, and advocating for violence. In which physical violence breaks out at a rally against people using their right to silent protest. In which white supremacist organizations can campaign for the front runner without harming his success. In which the simple hashtag "Black Lives Matter" has become a campaign against racial injustice because the world around us is telling us otherwise. In which the genocide against Native Americans still gets skimmed over in public school, the sterilization of Latina women in California is ignored. In which the white supremacist terrorist group, the Klu Klux Klan, holds a rally in Anaheim, attacking protesters with American flags and receiving protection by the police. This very same organization that the GAP feels the right to throw in Black students faces by drawing comparisons to their acts of terrorism to abortion. In which 20 foot signs of lynched bodies, holocaust victims and the violence of police brutality is considered appropriate for a public campus. In which these same signs disrupt many students days and intimidate many others from even coming back to campus. In which inaccurate images and facts on abortion are willfully given out in front of a "Hall of Science". In which doctors and clinics that perform abortions are actively targeted for bombing and receive death threats daily. In which the "Take Back the Night" event needs to take place late in the day, away from classrooms for fear of disruption but men holding signs and yelling at the top of their lungs about how women are whores and homosexuals are sinners is not disrupting. This context in which members of the LGBTQIA community continue to be murdered, thrown out of home and denied public services such as homeless shelters. In which Colle Carpenter, a transgender student at CSULB, had the word "it" carved into his chest only 5 years ago for simply existing. In which President Jane Close Conoley sends out emails telling us student safety is the number one priority.

By allowing these groups to come on campus without any regulations or restrictions the administration is complicit in each one of these acts of violence against its students, whether on campus off of of it. We cannot know what each student goes home to and to claim this campus as a safe space, a haven from other ills, while still allowing groups that call them murderers or sinners is a betrayal to each one of us.

whoever had the biggest wallet, and supporters of the GAP camp onto Safe Space CSU's reserved section to harass protesters. When asked what the police could do about it on Tuesday, they told us nothing and in turn the protest got out of hand. On Wednesday when GAP supporters came into our area again we learned that because we had reserved that space they could have been removed by police. Because of this the protest was much more calm.

- 3. Continued counseling provided by the University during the days the GAP are present.
- 4. A campus wide email regarding information on the GAP including where they plan to set up, options on how to avoid them and information on the counseling resources and their locations during and after the GAP presence.
- 5. We want a restriction on the size of the signs because much of this suffering could be avoided if we could just avoid them.
