3) <u>Discussion Item</u>: Senate Meetings

Chief Justice Vargas has already assigned dates for future meetings and informed the Judiciary that if they have a class conflict during the Senate meetings, to please work with Ms. San Miguel to obtain a letter for your professor requesting permission to be excused.

4) <u>Discussion Item</u>: Grade appeals based on colleges

Chief Justice Vargas reported that colleges have been assigned to Justices. Justice Olivas voiced concern about a conflict of interest because her major falls within her assigned college. Justice Vargas determined it is a conflict of interest and Justice Olivas will trade her assigned college with another Justice.

5) Discussion Item: 2-3 Committees

Chief Justice Vargas stated that he would like the Justices to serve on two to three university committees and when they attend those meetings they will be required to complete a report. He also encouraged the Justices to make sure and exercise any voting privileges on the committees they sit on as part of shared governance and to ensure student input.

Chief Justice Vargas encouraged the Judiciary to participate in Week of Welcome and that there is a sign-up sheet in the Student Government Office. He would also like the Justices to promote student government as a whole and spread awareness of Judiciary resources. This can also be accomplished by attending club meetings.

7) Discussion Item: Know Your Rights Campaign

Chief Justice Vargas informed the Judiciary that the Know Your Rights campaign last year was composed of four events: grade appeals, renter's rights, legal services and interacting with the police. He will be looking at dates to schedule the workshops and will send out a calendar.

8) Dr. Thomas Malizia Training Session

Dr. Malizia introduced himself to the Judiciary. Training sessions are required; he will tailor training sessions to meet the needs of the group and towards those interested in law school.

Dr. Malizia asked if the Judiciary will still be pursuing the Pro Bono resource. Chief Justice Vargas responded that it will continue to be a part of the *Know Your Rights* campaign.
