Chief Justice Vo played previews from the HipHughes' History Bill of Rights and another video link provided by Dr. Bryant. The board preferred the CrashCourse's Freedom of Speech #25 video. San Miguel asked the board to review the video in full for appropriate and relevant content and for play cut-off time.

4) Discussion item: Grade Appeals Video and/or Syllabus

Justice Chaney and Chief Academic Officer Jordan Doering had been collaborating effort to including grade appeals into the ongoing syllabus reform. The Academic Senate did not approve the initial request to be included in the spring 2018 syllabus. Chaney and Doering are waiting for the end of semester hearing date to present the request again, which most likely will be accepted to include grade appeals into the fall 2018 syllabus.

Chaney has been working with ASI Communications video team on finalizing video content outline of three minutes. The decision was made not to feature a current judiciary member so the video would not be dated. The original intent was to include video link in syllabus and consecutively release the video; however, since syllabus will not be available for spring 2018, does the judiciary want to release the video prior to fall 2017?

San Miguel reported that directive was given to ASI Communications for video to be ready by finals week in order for students to be aware of that option within the forty day rule for spring.
