San Miguel: create script foundation, send to Lobby Corps for their review/input before Spring Break, and return to Judiciary. Reminded that filming time and editing time need to be taken into consideration.

Lizarraga: requested that the joint collaboration script be presented at the next Judiciary meeting for Judiciary review and input.

Velasquez: collaborating with Forestiere on a Renters Rights; event date/time has been secured; advertising work order has been submitted to ASI Communications; working on securing guest speaker; emailed three organizations (Legal Aid Foundation of Los Angeles (LAFLA), Fair Housing, and CSULB Political Science Department) for guest speakers.

San Miguel: in the grade appeals policy, is there a timeline requirement to form a grade appeals committee once an appeal has been filed? They've been notified by a graduate student that they and half their class filed appeals for a fall class and they've yet to be notified of their appeal status and a hearing date.
