1) Discussion Item: 2020 ASI Elections Handbook –GEO Helen Rodriguez **TC 12:40pm**

Rodriguez reviewed the following handbook revisions:

- Page 4 #C-1-F: Make-up Candidate meetings will not include a photo shoot by ASI Communications
- Page 6, corrected contact information for campaign activities
- Page 7-K: Purchasing ads in 22 West Magazine, Daily Forty-Niner or ads for social media
- Page 7, Added on P: Candidates that are current ASI officers and/or employees may not wear ASI gear in candidate and campaign photos or at election events
- Corrected the wording under the digital platform on page 7 4-B: All social media containing campaign material cannot be posted until campaigning begins
- Page 7 4-F: Use of ASI social media sites (Facebook, Twitter, Instagram and Snapchat) is strictly prohibited with the exception of the ASI Student Government election account

2) Discussion Item: KYR- Formerly Incarcerated Students

Conlon:

- Re-doing it and it's looking good
- They have one question about the Isabel Patterson housing right, they don't see it restricting them

San Miguel:

- For housing on campus, they could contact Housing Executive Director Corry Colonna; For Isabel Patterson, it's not housing but student parents; contact IPCDC Director Alec Colchico to verify.

3) Discussion Item: KYR-Title IX and Sexual Assault

Forestiere: Asked for an event planning update.

Bui:

- They have been confirming and re-confirming with the resources in getting parking passes, getting contracts sign, updating of reservations for tables
- Next week, told the board to show up at Southwest Terrace, by Starbucks, 12-3pm
- Still waiting for ASI Communications order

Forestiere: They sent a message to ASI Communications this morning that they need to table

Bui: Need volunteers.

Saephan: Are there any groups that they haven't reached out to?

Bui: They emailed Pan-Hellenic, but they never heard back

San Miguel: It might be helpful from the day of – if they could set up a sign-up genius for volunteers – so they know who exactly is helping to meet at the student government office and bring out all the office supplies needed. And of course, having someone out there to able to greet and check-in on/off resource organizations and then talk about who needs parking passes. With this, we would know where we need to fill in or where we might need more people.

Conlon: With the 12-3, is that when it starts and ends?

Bui: For people to come to the event, that's 12-3pm. Set-up time is at 11am, and clean-up is at 4pm.
Forestiére: We can open this up to student government to maybe can get more help.

Forestiére: Asked for candid board member feedback on board's progress, and what we can do to improve.

Saephan:

- We started the year very ambitious, which having a lot to get things done in a short amount of time.
