- On behalf of Terri Carbaugh, Farmer asked what the board's thoughts were on this program ending

8. NEW BUSINESS

A. Lobby Corps Orientation

Chair Jara explained the role of Lobby Corps within ASI:

- Sub-committee of the Senate committed to make student's voices be heard at the state level
- Partnered with CSSA, California State Student Association
- Responsible for coordinating legislative lobby visits, which will be district office visits and capital visits once they go to CHESS in March
- Coordinate voter registration drives and educational campaigns
- Track legislation concerning students
- Maintain relationship with CSSA, CSU Board of Trustees, and Long Beach City Council

B. Approval of Lobby Corps 2017-18 Working Rules

San Miguel summarized the purpose of the working rules and the changes that have been implemented since last semester:

- Went from 4 Students-at-Large to 3, with each student focusing on a specific role: CSU BOT, City Council
 and District Visits
- Senate created a by-law change stating that any officer that is elected by the Senate can be removed by them if they are not upholding their responsibilities

C. Election of Vice Chair

- Assist the chair and committee, as needed

D. Recommendations from 2016-17 Lobby Corps

Genesis went over the recommendations from the previous committee:

- Continue looking for a long term funding source and have Board of Directors approve it
- CA AB1062 Post Secondary Education Trustees
- CA AB393 Public Postsecondary Education: Mandatory System Wide Fees and Tuitions
- Voter registration drives suggestions
- Issues of interest
 - o Homelessness
 - Food security
 - o Tuition and fees

E. Lobby Corps Policy Agenda

Chair Jara opened up the floor for discussion and asked committee members to share any issues of interest for the upcoming year.

Carancho discussed the RISE campaign, a non-profit focused on making college tuition free statewide for families making 150k or less; they are trying to gain student support for the campaign. Carancho stated that a link would be sent on the Facebook page.

Musman brought up mental health issues and attempting to gain more funding for support programs and counseling and assisting students in gaining access to these resources.

Argent discussed the housing and food insecurity issue on campus and hopes that it will be something they can work on throughout the year.

Kilian would like to focus on the undocumented students and reiterated that with the DACA program not being renewed, it is something that should be worked on very closely.

F. Student-At-Large Areas of Focus

Each student will have a different emphasis and they will be assigned at the next meeting.

Jurado explained that pages 3 and 4 of the Working Rules explain what the roles of each of these areas would be.

San Miguel emphasized that attending these meetings and taking notes are important in order to report back to Lobby Corps after each meeting.

San Miguel shared some information regarding an undocumented DACA support group on September 6th from 10am-3pm in USU-307. They will have some information available there such as an immigration attorney, CAPS and Dream Success Center resources.
