6. REPORTS

A. Chair/Government Relations Officer

Chair Jara reported the following:

- CHESS is this weekend. Jara will be leaving Saturday morning to attend the CSSA Plenary, and the rest of the group will be leaving on Saturday evening.
- Do not forget to pick up your CHESS per diem from the Business Office before you leave
- CHESS assignments have been finalized and are on the Excel sheet. Also asked everyone to meet with their group before so that you can discuss the issues and help all delegates become comfortable with the process
- Submitted the work order to ASI Comm for their tuition increase efforts and events. Presented the board with different themes, designs and mood board and asked the board for input
 - o Carancho liked the red and black and thinks they should keep the red so that they could tie it in

to SQE

- o Farmer expressed that they liked the red and yellow and feels that it expresses the urgency of this issue and is more attention grabbing

 extremely long meeting (around 7 hours) and they discussed the land use element. Something they
 should consider when discussing the housing issue is the fact that there is just not enough housing in
 Long Beach, so this land use element could benefit CSULB students.

D. Senate

Senator Mejia reported the following:

- Passed 3rd Reading: Resolution for the Retirement of Prospector Pete and the Disassociation from the Gold Rush era
- Passed 2nd & 3rd Reading: Reading on California State Legislative Bills of Interest
 - o Carancho will be sending the final resolution for bills that they will be supporting to the board
 - Musman suggested that they proof read the resolution, print it out on nice paper, and then they can sign it along with President Nino
 - Jara stated that they don't think they need them signed or on nice paper since it is just going to be used as a point of reference for CHESS delegates during legislative visits
 - Jurado said that in the past they have given legislators a copy so that they have that as a reference and is used as one of the leave-behinds

7. OLD BUSINESS

A. Discussion Item: Tuition Increase Efforts

Jara stated that they are still waiting to hear back from Taylor at Beach Pride Events regarding funding before they can move forward with planning the town hall event.

Carancho said that they are waiting for literature from ASI Comm for tabling which is scheduled for Thursdays from 11-12pm. So far, Carancho, Olenslager-Orton, Jara, and Kilian will be the ones doing these tabling sessions.

Musman informed the board that they have a draft of the script ready for the board to review and they will be shooting the video on the week of 3/19.

Jara asked if they could discuss the basics of the script for the video.

Musman summarized that it is really short and they will be discussing Governor Brown's position, ASI's position, tabling events, invite students to the town hall meeting with state legislators, and then ask them to follow ASI on social media.

Carancho asked when would be the best time to reach out to student organizations and how would they organize tabling with other orgs.

Jara explained that they reserved about 4 different tables, but if they had other organizations come out, they would have to bring their own stuff. Cabinet would be the liaison between these organizations and Lobby Corps, but requested that they hold off until they receive their marketing materials from ASI Comm.

Mejia mentioned that Yamagiwa asked if they could mention SQE's efforts in the video they are doing with ASI Comm.

Jara thinks they can definitely do that and include their efforts and the ways that they have collaborated on this issue.
