Their goals are to build voter registration, inclusive education, and deferred maintenance.

### 2) Reyalyn Villegas

Villegas introduced themselves as a Molecular Cell Biology major, and reviewed their prior involvement and leadership experience as a pre-nursing student director, as the events chair for the Medical Students Association, and as a California Higher Education Student Summit (CHESS). Villegas goal is to increase student at-large involvement regardless of student background and believes their previous experience in publishing documents for incoming students would be an asset to the Lobby Corps Student At-Large position.

Almahdi: recommended postponing election of students at-large until the next meeting.

Mejia: voiced support to Lendrum and Villegas being strong candidates; concurred postponing in order for additional candidate inclusion.

Contreras: agreed that postponing election will allow more student involvement; would like to reach out to general students to gain interest; stated he can reach out to CLASC as he is the vice president.
