B. Discussion Item: Proposition Presentation

Student At-Large Villegas will be presenting on propositions that will be on the Nov. 6th ballot

Proposition 1: Affordable Housing Bond

- Allow the state to sell \$4 billion in new bonds to pay for existing affordable housing programs.
- Money will be appropriated into the following:
 - Low-income residents
 - Veteran support
 - Supporting Farm Workers
 - Accessible housing near public transportation

Proposition 1: Affordable Housing Bond

Why Vote YES:

- California is in great need of providing accessible housing for low-income families.
- California government should be able to provide for their veterans.

Why Vote NO:

- Passage of this will only benefit a limited part of the state population.
- California continuously acquiring debt will eventually result to higher taxes increased burden on the residents.

Proposition 2: Mental Health Housing Program

- Allow the state to sell up to \$2 billion in bonds to provide assistance in paying for new mental housing programs.
- Approximately \$140 million from Proposition 63 funds could be used to pay for these bonds annually.

Proposition 2: Mental Health Housing Program

Why Vote YES:

- California will be providing the best support for those suffering with mental illness by providing them with housing.
- Proposition 2 will not significantly affect the state budget. Why Vote NO:

- Decisions regarding how to deal with residents suffering with mental health illness should be up to the counties not the state.
- This proposition will only benefit construction companies.

Proposition 3: Water Bonds

- Allow the state to sell \$8.9 billion in new bonds in order to provide financial assistance to water and environmental projects.
 - Projects they will prioritize:
 - Watershed protection
 - Dam and reservoir repairs
 - Flood protection

Proposition 3: Water Bonds

Why Vote YES:

- California will be able to provide safe drinking water to its residents.
- This will allow California to be prepared for future droughts and/or floods.

Why Vote NO:

- Does not address California's main issue water shortage.
- Unnecessary funding for preservation of state parks.

Proposition 4: Children's Hospital Bonds

- Allow the state to sell an additional \$1.5 billion in bonds for hospitals geared towards children.
 - Hospitals must have an implemented system they can use to prove that the funds are being used appropriately.
 - Funds could be appropriated for the following:
 - Facility improvement
 - New equipment

Proposition 4: Children's Hospital Bonds

Why Vote YES:

- California should be able to provide quality care for children despite their family's income status.
- Hospital facilities across the state could use the improvements.

Why Vote NO:

- California does not need to acquire more debt.
- This does not address the main problem: improving the health care system overall.

<u>Proposition 5</u>: Property Tax Rules

- Allow the expansion of special property tax rules for the following homeowners:
 - 55 years or older
 - Residents with severe disabilities
 - Homeowners who lost their property to natural disaster
- Allow homeowners to continuously pay the same amount in property tax disregarding the location and how many times they move.

Proposition 5: Property Tax Rules

Why Vote YES:

■ Seniors and people with severe disabilities to relocate without worrying over paying higher taxes.

Why Vote NO:

- This will decrease the funding for schools and public services.
- It will only benefit seniors who can afford to relocate.
- This does not address the main problem: rent control and homelessness.

Proposition 6: Transportation Taxes and Fees

- Allow for the elimination of taxes and fees passed in State Budget #1 last year.
- Legislature cannot pass any new taxes on gasoline and diesel fuel prices without garnering voter approval.
 - Similar condition will be applied for any legislation surrounding vehicle license fees and transportation improvement fees.

Proposition 6: Transportation Taxes and Fees

Why Vote YES:

- Low-income residents are currently dealing with ridiculously high transportation taxes and fees.
- This can immediately lower the price of gasoline and vehicle registration fee. Why Vote NO:
- Approximately 6,500 state projects are funded by transportation taxes and fees.
- Passage of this proposition will put our state infrastructure at risk lowers the funds available for improving roads, bridges, etc.

Proposition 7: Daylight Saving time

- Allow for voting on changing Daylight Saving Time.
 - Lawmakers can choose to propose a law changing Daylight Saving Time into year-round rather than seasonal.
 - Changes must garner support from 2/3 of California's Legislature.

Proposition 7: Daylight Saving Time

Why Vote YES:

- Year-round Daylight Saving Time would have positive health effects on the public.
- This can reduce energy costs and increase work production.

Why Vote NO:

- School activities, traffic and public safety will experience negative effects during winter.
- This will create confusion since we will have a different time from other Western states.

<u>Proposition 8</u>: Kidney Dialysis Clinics

- Allow limitations to be put on treatment fees at dialysis clinics.
- Clinics would have to report how much profit made, summarize their patient charges, and their expenses on providing services.

Proposition 8: Kidney Dialysis Clinics

Why Vote YES:

- Put limitations on fees dialysis companies can charge their patients.
- A step towards lowering healthcare costs for Californians.

Why Vote NO:

- Dialysis clinics will not be affected by this since they already provide one of the highest quality health care.
- Community dialysis clinics will force to decrease the services they provide.

Proposition 10: Local Government and Rent Control

- Allow changes to be made on state law and put control on local governments regarding rent control.
- Rent Control Law could apply to any type of housing no matter when it was built.
- Allow local governments to put restrictions on landlords including:
 - Increasing rent for new occupants

Proposition 10: Local Government and Rent Control

Why Vote YES:

- High cost of rent is putting seniors and low-income families at a disadvantage.
- This will allow local communities to choose whether they want to implement rent control.

Why Vote NO:

- Rent Control will hurt landlords it can force them to sell their properties instead.
- This can possibly increase rents rather than controlling it.
- Government should not have the right to tell single-family homeowners how much they should charge for rent.

Proposition 11: Ambulance Employee Breaks

- Allow private ambulance employees to remain on-call during their shifts.
 - They must respond to emergency calls during meal and rest breaks.
 - They must be provided another break time if they do respond to calls.
 - Their break rates should be equal to their regular rate.
- Ambulance companies will be required to provide paid training and mental health services.
- This will not apply to public ambulance employees.

Proposition 11: Ambulance Employee Breaks

Why Vote YES:

■ This will put protection on public safety and ensure private ambulance companies will respond effectively to any type of emergencies.

Why Vote NO:

■ No argument.

Proposition 12: Farm Animal Cages

- Allow for creation of specific rules about the size of cages and crates for animals like pregnant pigs, egglaying hens, and cows.
- This would deem selling meet or eggs from animals kept in cages that do not meet the rules as illegal.
- It envisions that in 2022, farmers should be required to keep egg-laying hens out of cages.

Proposition 12: Farm Animal Cages

Why Vote YES:

- Having no requirement for animal cages is cruel and unsafe.
- By putting requirements, we can reduce the risk of food poisoning and farm pollution. Why Vote NO:
- This does not address the main issue: protecting farm animals.
- Cage-size requirements will not be sufficient in protecting all types of egg-laying hens.
