A. Discussion Item: Measures Presentation √
Maya presented the Long Beach 2018 Ballot Measures

Measure AAA: Auditing

A yes vote is a vote in favor of (1) amending the city charter to allow the city auditor to conduct independent audits of city departments, boards, commissions, and offices, and (2) changing language in the city charter regarding the auditor's access to reports and contracts.

Measure BBB: Term limitation

YES: in favor of amending the city charter to change the term limits for the offices of mayor and city council member from two terms with unlimited opportunities to run as a write-in candidate to a maximum of three terms within a lifetime.

Measure CCC: Ethics Commission

A yes vote is a vote in favor of amending the city charter to provide for a seven-member ethics commission, to be appointed by the mayor, city auditor, and members of the commission with confirmation by the city council <u>Measure DDD: Redistricting Commission</u>

A yes vote is a vote in favor of amending the city charter to establish an independent citizens' redistricting commission to draw district boundaries.

Measure WW: Hotel Restrictions

If approved by the voters, it would require a hotel in the City of Long Beach to supply hotel employees with an electronic contact device, for summoning on-scene assistance and reporting threatening conduct. Measure "WW" would prohibit a hotel employer from requiring a hotel room cleaner to clean more than 4,000 square feet of floor space in any eight-hour workday unless the employer pays twice the regular rate of pay for all hours worked.
