University Affairs Committee

- ASI should have funding for students at-large to go to CSSA meetings.
- Several amendments were made on the Resolution Regarding Student of Color Safety and Justice for Josiah
- CSSA's Say on Pay Resolution and Resolution for Transparency and Shared Governance in the Selection of New CSU Presidents have been passed.
- Dr. Woods provided update on Graduation Initiative 2025

Graduation Initiative 2025

• Seeks to increase graduation rates across the CSU system while eliminating opportunity and

achievement gaps.

• In the 2017-18 academic year, 105,431 undergraduate students earned their degree – a record high for the CSU with 6,600 additional students graduating compared to the previous year

Social Justice and Equity Committee

Amendments made on Resolution in Opposition to Proposed Title IX Changes Regarding Student Sexual Assault and Harassment Cases

Director Reynas (CSU Bakersfield) led a discussion about Undocumented Campus Employment

Legislative Affairs Committee

Committee has voted on the following legislative bills:

1) AB 13: Higher Education Facilities Bond Act of 2018

This will allow the use of \$7 billion to build more student housing, address the massive backlog of deferred maintenance projects, and possibly open up a new CSU.

2) SB 14: Higher Education Facilities Bond Act of 2018

This would authorize the issuance of an amount not to exceed \$8 billion to alleviate the backlog of infrastructure maintenance.

3) AB 140: CA Kickstart My Future Loan Forgiveness Program

This will provide student loan forgiveness awards to eligible applicants for up to 24 months after graduation.

4) AB 532: Parking Bill

Three years after being enacted, equitable prices for parking permits in all CSU campuses.

5) Student Athlete Bill of Rights

This bill would require higher institutions to provide athletic scholarships and provide an equivalent scholarship to students who do not have their contract renewed.

6) Rapid Rehousing Bill

This bill would take an already existing best practice in the field of "homelessness" and tailor it to higher educational institutions.

7) AB 540: Competitive Cal Grant Access

This would ensure that all forms of state-based financial aid in California are made equally available to
