Villegas: Spoke to Chief Velasquez regarding having personal stories attached to the Thank You Letter Contreras: Supported the idea, but the letters should come from student advocates.

Deng: As a closing statement, there should be an ASI point of contact to establish a relation with the representative.

San Miguel: To expedite the process, there could be one story from a board member. Regarding the point of contact, it should be the ASI Government Office.

The board decided on having statements from the board, instead of a story. They will sign off the letter by the next meeting.
