C. Discussion Item: 2019-20 SMART Goals

Padilla: Wanted to move up CHESS advocate date; Submitted the work order; CHESS – March 7th to 9th

S.M.A.R.T Goals are designed to help the team identify if what we want to achieve is realistic and determine a deadline. These goals will help us succeed in our advocacy efforts this academic year.

2020 CHESS Applications

To increase the preparation of CHESS delegation and build relationships, applications will open the first week of October. Interviews will be conducted by November 8th 2019 or the 15t and the final delegation will be decided by the first week of December.

Specific: Have a delegation by early December so we can begin connecting the delegation prior to the conference date (March 8-9th 2020).

Measurable: Accomplishing our objectives by each specific deadline set.

Achievable: Yes, by staying accountable by our own deadlines.

Relevant: It is crucial that we have a CHESS delegation as soon as possible, this aligns with our objectives of advocacy and lobbying.

Time-Bound: Applications open \rightarrow Early October Interviews \rightarrow November 8th or 15th Decisions \rightarrow Early December

Advocacy Day

To hold a one-day advocacy event after CHESS with on campus and off campus groups in order to increase civic engagement. Begin planning in the Fall since we want to double our participating on and off campus organizations as well as student body attendance.

- Specific: We want to have students learn about resources on/ off campus to be empowered.
- Measurable: Receive feedback through event questionnaires and get post-its to see ask students for what we could improve.
- Achievable: Reserve the location, create graphics, send in work orders, & set up tables which is doable.
- Relevant: Informing students about Lobby Corps and get them involved with

- ASI. This event will help support us in bringing visibility on campus.
- Time-Bound: Discuss a theme and decide it by mid-November, email organizations by December. Also organization should be emailed by December to keep our goal realistic and tied to our policy agenda which would be set by October 3rd.

Automatic Voter Registration

For this academic year (2019-2020) our committee will begin researching how we could bring automatic voter registration to our campus so that we can increase voter registration through our enrolled students.

- Specific: To increase voter registration within the CSU system.
- Measurable: Creating the narrative within administrative meetings, CSSA,
 & within other leaders on campus during the Fall semester.
- Achievable: At the moment we only have UCLA as an example, but that just means we need to do research on how we can present this initiative to administration for our campus.
- Relevant: Although it would be a long process the idea is to begin the conversation now and see how it could be implemented at our campus.
- Time-Bound: Academic year 2019-2020 project.

Collaboration

To establish at least four (4) collaborative partnerships between student government, department organizations, and committees to inform and expand Lobby Corp's efforts by the end of Fall 2019.

- Specific: Increase collaboration and community involvement in order to further the mission of the Lobby Corps and represent the campus population more.
- Measurable: When holding all members on the committee accountable for outreach on campus. As well as measurable through the efforts of finding volunteers when needed.
- Achievable: Yes, through keeping the committees that we collaborate with and other individuals on campus in the loop (transparency).
- Relevant: To ensure greater participation in legislation and ensure that both the representatives and constituents have a platform.
- Time-Bound: By the end of Fall the collaboration between other groups on campus should be apparent.

District Visits

Establishing four (4) legislative visits throughout the Fall semester in order to help prepare our committee for CHESS and share our policy agenda with our representatives.

- Specific: Establishing a relationship/ awareness with representatives before CHESS... Requires the Chief Government Relations Officer and 1-2 other members from Lobby Corps.
- Measurable: The committee agreed on a minimum of four (4).
 Achievable: Through reaching out both to our representatives and University Relations this is possible.
- Relevant: Setting the meetings can become difficult so it is important to set the goal now.
- Time-Bound: Facilitating the meetings during the Fall semester.

Voter Registration Drives

Hold three (3) voter registration drives this academic year to increase student voter registration (1 September, 1 November, & 1 in early February 2020). This is important since the California primary elections have been

moved from June to March 3rd 2020.

- Specific: Increase student voter registration demographics through the collaboration from other organizations such as Rock the Vote and the California Common Cause.
- Measurable: Through setting the dates at-least a month and a half early for each drive.
- Achievable: Through event planning and collaboration.
- Relevant: Setting this goal will support us in the focus of California's primary and general elections 2020.
- Time-Bound: One (1) Thursday, September 26th for Voter Registration Day, one (1) early November, & one (1) early February before the February 17th deadline for the general elections.
