8. NEW BUSINESS

A. Discussion Item: Basic Assistance for Students in College (BASIC) Act

Padilla: CSSA will be voting on if they will support the Act; this will be in conjunction with Policy Agenda; asked board for questions to take to CSSA.

Deng: how is it going to be determined what types of basic need research is going to be allocated funding?

Prado: are non-Pell grant recipients/low income students eligible to receive this money?

B. Discussion Item: SB 206

Babineaux: Athletics Director Andy Fee has spoken out on university's stance of not supporting bill; our athletes wouldn't benefit from this bill because we don't have a football team or a big basketball team name recognition; Governor has not signed it yet; What we need to look at now is scholarships for student athletes.

McManius: University has concerns and is against it; The schools that would benefit from this SB 206 are the one with huge football and basketball programs; Chancellor White has sent letter to Governor asking them not to sign it.

C. Discussion Item: Voter Registration Training Padilla: Displayed a presentation about Voter Registration Training; Talked about who can register to vote, voter registration counties, and completion of affidavit
