A. Action Item: Election of (1) Lobby Corps Student-at-Large – Hannah Peedikayil TC 2:40pm Peedikayil introduced themselves as a Health Care Administration major, and reviewed their involvement with HOSA Summit, Beach Pride, the Student Health Center, and with Beach Team. They applied for Lobby Corps to get involved in legislation that directly impacts them and students. Their concerns are campus safety, students in foster care. They would promote student involvement through workshops.

- B. Discussion Item: Governor Newsom's Proposed Budget for 2020-21 Velasquez:
 - CSU budget: \$554 million requested, \$199 million granted; after compensation, salary, etc. only
 \$30 million would be left for all 23 CSU campuses
 - The reason why this year's ask is high is because we included a graduation initiative

- The reason why last year's budget award was significantly higher was because it included a onetime award for Basic Needs
- After budget is presented, there'll be a May revise and then finalized in June

C. Discussion Item: Census 2020 TC 3pm Connie Low, partnership specialist for the US Census Bureau reviewed the Census process, and its importance of reapportion Congressional seats which affects redistricting (local, state, federal).
