A. Information Item: Lobbying Training

What is Lobbying?

• The process of meeting with your politicians and expressing your legislative interests with the purpose of influencing the politician to vote for those interests.

What are Our Legislative Interests?

- We represent students and their interests
- We use our Policy Agenda to advocate and choose bills that align with those goals
- We will do research on bills and pass a "Bills of Interest" resolution through Senate

What is a Legislative Visit?

- A scheduled meeting with a legislator
- We will be advocating for our legislative interests
- Requires preparation and collaboration

How do you Run a Meeting?

- 3 Roles
 - Facilitator: will facilitate the meeting and conduct introduction/closing
 - Story Teller: will provide the "meat" or the "pitch"
 - ✓ Provides the name of the bill being discussed, as well as our position on it
 - ✓ Provides a statistic of some sort to demonstrate why the bill would be helpful for students
 - ✓ Tells a student-focused story or anecdote related to the topic of the bill

Try It!

- We will each choose silly tops and practice the "storyteller" role
- Remember
- · Name of bill and its content
- Statistic
- Student story
- Note-taker: small speaking role, takes notes for the meeting
- Allow the legislator time to ask questions

Lobbying Tips

- Remember to give the legislator time to ask questions
- Never lie: "I do not know the answer to that question at this moment. Let me make sure I receive the correct information and I will follow-up with you regarding that issue."
- Legislators LOVE meeting with students!
- Be prepared and collaborate with your team in advance
- Read the room
