VP Vournas and executives will have a campus wide forum in order to inform students and listen to the students about their concerns over the tuition increase.

Mr. Haller stated there was a previous attempt to oppose the tuition increase, called Vent Tent where students were video-taped voicing their concerns over how the tuition increase will affect them.

VP Vournas reported that the executives plan on moving forward with the forum, collecting student narratives, SQE cards, spreading information to the entire student body, and Lobby Corps transition from voter registration into phone banking.

Sen. Cabrera asks if President Conoley had any action towards this.

VP Vournas replied that President Flores had already contacted President Conoley about what ASI should do about the increase. President Conoley said she will stand in solidarity with the students and support the opposition of the tuition increase.
