Joel Deas, stated the following:

- Students of all colors witnessed hate
- We know this hate is anti-Semitism (demonizing)
- Resolution is anti-Semitic
- "This body cannot claim to seek peace and at the same time challenge Israel's right to exist"
 - George W. Bush

Jeff Blutinger, Professor of History of Israel and Palestine, stated the following:

- Historical errors in this resolution
 - o Continued reference to the state of Israel as a colonial occupying power
 - Israel was established by the United Nations
- This resolution calls not for coexistence of Israel but it's elimination

Ari Edelman stated the following:

- References J.K. Rowling who said no to divestment
- "At a time when the stigmatization of religions and ethnicities seems to be on the rise, I believe strongly that
 cultural dialogue and collaboration is more important than ever before and that cultural boycotts are
 divisive, discriminatory and counter-productive."
- Voting no means you stand against divisiveness and discrimination, and for peace along with J.K. Rowling

Abhishek Manjulagodu Basavanna stated the following:

- How does a nation protect itself from random attacks
- The actions of Israel are not justified, but they are slowly reactions to what has happened
- Divesting from these companies will have zero effect on the companies and have a huge impact on CSULB and the community

- In support of students trying to talk about this critical issue

Kazuki Okamoto, Exchange Student from Japan, stated the following:

- Working as a sound engineer with Israeli individuals
- Traveled to Israel
 - o Arabs and Jews eating together, co-existing

John Motter, CSULB Alumnus and Former Marine, stated the following

- Occupation dehumanizes and alienates the subjugated people
- This does nothing to move towards the peace process
- Completely absurd that anyone would support the companies listed

Suzanne Wechsler, Professor at CSULB, stated the following:

Saddened by the lack of constructive academic engagement around this issue

- Crucial context about the situation in the West Bank, Gaza, and state of Israel has not been provided
- One-sided focus does not give critical information
- Act with integrity, please do not pass this resolution

Jose Espinoza stated the following:

- Student voices are being silenced
- Expressed concerns about the students on campus

Chase Niles stated the following:

- BDS is purely a political stance, it has nothing to do with companies and life on campus and has no intention of creating peace
- Why is this hateful condemning of only Israel but no other countries whose government is murdering their citizens
 - o Syria, North Korea, or Iran

Benjamin Goldstein stated the following:

• This campus is inclusive, but by passing this resolution will affect pro-Israel and Jewish students on campus

Adriel Cruz stated the following:

- Focusing on the minority compared to majority of campus. Why?
- Why not punish South America or the Philippines
- Campus is supposed to be an inclusive space

Tali Shaddaei stated the following:

- As a former senator, they know what it's like to be in this position as the voice of students
- Look at the effects of the resolution and it hasn't reached a 2nd reading
- Look at how divided we have become, is this what you imagined your leadership would bring?
- The weight your vote has on the climate of this campus

Josh Burger stated the following:

- Divestment resolution forgets to acknowledge that Israel is the only safe haven for the Jewish community
- Support the struggles of Palestinians while condemning the citizens of Israel
- Divisive language prioritizes other nationalities over others, as if one is more important than the other

Spencer Potiker, self-identified Jewish Student, stated the following:

- This is a not a religious issue of Jewish vs. Muslims
- This is a moral issue of those living in refugee camps with no rights
- These companies are perpetuating violence on the Palestinian people

Jonathan Grunin, self-identified gay Israeli, reported the following:

- Ted Cruz, creating policy for gay individuals and has the right to create them
- 36 states in the U.S. where you can be fired for being gay and certain rights and privileges taken away

Chaya Leah Surfing stated the following:

• "I have directed my Administration to strongly oppose boycotts, divestment campaigns, and sanctions targeting the State of Israel. As long as I am President, we will continue to do so." – Barack Obama

Courtney Yamagiwa stated the following:

- Does not want tuition fees to go towards Palestinian Oppression
- Your decisions today will have an impact on others tomorrow and days to come
- Be brave and call for divestment now, be part of the change before it's too late

Zainab Syeda, Student Representative from Muslim Student Assn., stated the following:

- Support the divestment resolution
- One minute is not long enough to explain the issue
- Other groups of students are here to delve into these issues

Jada Johnson stated the following:

Black Lives Matter, not one has mentioned that Black lives also matter

Fatimah Alghnueir stated the following:

- Human rights and social justice issues taking place in Palestine
- U.S. funds military support to increase militarization

Aliyah Z. Shaikh stated the following:

Sen. Cabrera objects the call to question as there are more questions from the board.

Sen. Musman asks for Line #133 to be removed which states: "the support of private prisons and aforementioned violations of international law and human rights by Israel"

VP Vournas, as a co-author of this resolution, speaks to the idea that this is an intersectional issue and are all highly intertwined. They expressed that they will not remove the clause unless the board votes to do so.

Sen. Azam, as an author of the resolution, states that the resolution discusses the divestment of companies profiting off of the exploitation of the Palestinian people and contributing to the violence. They urge everyone to read the resolution and what it states.

Sen. Musman notes that they find the language of the resolution to be marginalizing the Israeli people. If they are aiming the resolution towards specific companies that are violating Palestinian human rights then they should change the language of the resolution. More specifically, a whereas clause stating that "Israel has been an occupied state since 1948", where in 1947 the United Nations established the divide between Arab-Palestine and Jewish Palestine.

Sen. Musman also asks why the authors specifically chose companies that do business with the Jewish state, why can't they include other companies who are doing business in other countries and why they are focused on Israel.

Sen. Azam and Sen. Elasmar, co-authors of this resolution, gave responses as to why they specifically chose those companies and the area in which they do business.

Discussion ensued on whether CSULB is actually invested in these companies.

VP Vournas, a co-author of this resolution, expressed the idea that the value of those in authority should not be taken more seriously just because they have more authority.

Rachel Kaplan reported the following:

- Hearing Senate say they are voting on whether you want to marginalize one group over the other
- Trying to understand how this creates inclusion
- Divestment does not allow pro-Israel to support pro-Palestinian
- Open to building a community with social action process but it is not what divestment does
- Anti-Semitism is defined as hostility towards or discrimination towards Jewish people
 - o Telling me that this is not an issue about Jews, tells me how to identify with Israel as a homeland
- Singling out Israel as the only Jewish homeland is anti-Semitism

Dale Lendrum reported the following:

- 3 violations of bylaws taking place
 - Not a single individual expressed concerned over it
- How many have gone to colleges with vote or resolution stating their support or not support of this
 resolution
- They elected you to be their voice to vote for what they believe in, not what you believe is best on their behalf
- The board should table this item and allow the true voice of students to come out

Tali Shaddaei reported the following:

- Before the 2nd reading was passed, one of the speakers for the resolution, called another student, who was opposing the resolution, a terrorist.
- If this isn't a rise of hatred on campus, then what is
- They feel that walking across campus they do not feel safe
- Cannot have open dialogue with anyone
- Passing the resolution takes away from open discussion between different religions, race, and beliefs

Javeria Syed reported the following:

- Thanks the senate for passing
- Anti-Zionist is not anti-Semitic
- Please listen to our pleas, our lives matter

Bryana Olmeda reported the following:

- As a former senator, they were met with opposition when writing non-discrimination resolution
- To speak as an ally to support the needs and voices of Palestinian people

- Read what the resolution is stating and what the authors are trying to divest from
- It is not going to be comfortable and it's not going to be easy but it is necessary

Spencer Potiker reported the following:

- Thanks the Senate for taking a stand against global injustice
- Thanks the Senate for the dialogue on delinking anti-Semitism and anti-Israel rhetoric
- Does not want to be associated with apartheid state
- Hope that it sets a president with other injustice

Fatima Aldelhateez reported the following:

- Thanks the senate for voting to pass the resolution
- Important for the student body to decide if we are going to be socially responsible investing
- Divesting companies from the companies who are not socially responsible

Jonathan Grunin reported the following:

- Pro-Palestinian and pro-Israeli
- Resolution harms Palestinians, where companies provide homes to Palestinians and employ them
 - Soda Stream, Caterpillar

Geoff Tripp reported the following:

- Thanks Senate for voting for what you want to see in the world
- There is a set of international laws
- Everyone has told Israel they are in violation, but they are ignoring them

VP Vournas addressed their vote and why they decided against abstaining.
