They expressed their intent to work specifically on hate speech on campus and protecting the community while also promoting outreach.

## f) Marissa Murphy

Candidate Murphy is a political science major who believes social justice is incredibly important. They discussed their initiatives to ensure safety and comfort on campus for student, and hate speech policy.

## g) Yajaira Negrete

VP Musman presented Candidate Negrete's statement on her behalf in her absence. Candidate Negrete shared personal experiences of discrimination and determination in overcoming challenges. Negrete stated commitment to awareness, education, and action to campus issues to make CSULB a positive and safe space for dialogue and growth.
