Jordan: California Law recognizes abortion as a student need, which provides leverage for the board to take a stand on the issue.

Maya: The Focus of the discussion is not regarding the moral principles but advancing the status of women in California. Everyone should have access to reproductive rights; each university that opts in the program would receive a \$200k grant to fund the program.

Fukuda: There are resources for pregnant women on campus such as pre-natal vitamins available at the Health Center; they sit on the Health Center Advisory Committee with Phong, and they discussed the action moving forward with the program. The service would be only with medication abortion, and no surgical service.

Guzman: There are services at the Student health center such as pregnancy choice counseling, HIV Testing, workshops and referrals for services.

Canales: Reached out to the Health Center, they would not be prepared for this program at the moment. However, it will not be implemented until 2023 and there is funding for training -1 have a strong believe that the time and training will be able to make accommodations for this.

Major: Wants to have more opinion from the Student At-Large population.

Martinez: Hearing students talk on the issue helps in deciding a stand on the bill.

Fukuda: Students will seek the abortion service if they want to, the bills is regarding if we want the students to go through many obstacles to achieve what they want in the first place.
