10. NEW BUSINESS

A. Discussion Item: Recommendations for the 2019-20 Senate

Canales returned to Chambers.

Almahdi: Historically the board recommends resolutions for the next academic year board. Chair Almahdi then opened the floor for discussion.

Canales: Recommended getting Senators pictures earlier so students know who are representing them.

Prudencio Gonzales: Fixing language on the ASI Bylaws regarding Formalities and Working Rules. Also, creating election rules that does not allow Legislative Branch candidates to run on slates with Executive Branch candidates.

Jordan: Disagreed with College Councils sending candidates for Senate for confirmations.

Maya: Added that Sub-boards should not need to have confirmations by the Senate.

Guzman and Contreras: Defended that Senate should have a final saying over confirmations from the College Council.

Fukuda: Also agreed with this point.

Krider: Argued that having the College Council deciding is a democratic way to filling vacant positions.

Haller: Asked if any of the members from College Council elected by student vote? Almahdi: Each representative is elected by their organization.

Haller argued that not being elected by the student body is the weakness of the College Council.

Fukuda: Recommended a Senate Training to incentivize bonding between Senators.

Prudencio Gonzales: Recommended policies to address the tardiness to meetings issue.

Jordan: Argued that each Senator should be responsible, without having a rule to enforce a behavior.

Aguilar: Having something to bring more discussion regarding to Athletics and IPCDC efforts in the Senate meeting.

McDonald: In addition, more collaboration with Greek life, Housing and other CSULB departments to bridge the gap with ASI.

Almahdi: Recommended Senators At-Large having focus on Housing, Graduate Students and other University segments.

Phong: Recommended ASI College Senators to develop a relation with Faculty and Staff Members rather than just the Dean.

Jordan: Recommended an updated version of what is similar to Beach 2030 initiative to ASI.

Maya: Recommended having Senator At-large meetings.

Aguilar: As discussed, our plan is to replace the community member with an alumni member to have more consistency and meet the quorum for our meetings. There was also some clean up on the language.
