## **Work Completed:**

- Attended Week of Welcome, Engineering Week of Welcome, and the Welcome Back Event hosted by Vet Net to conduct outreach.
- Visited outside veteran services offices to see what was provided and how we could improve.
- Researched grants applicable to Veteran Service Office to gain additional funding.
- Collaborated with Veteran Services Office for the Game Night at the Nugget.
- Set-up the framework for the Veteran 5K to be reestablished, however Vet Net has decided as of 10/28/2019, that they want to go with a different event.
- Did outreach through 22 West radio show, A Mindful Moment, for events and commissioner role.
- Collaborated with Vet Net for the Meditation Week event, and we are continuing to work on the Social Event and Alumni Mixer.

# E. Information Item: ASI Commissioner for Pregnant and Parenting Students Joelle Bobadilla Work Completed:

- All campus shuttle employees have been informed that children are able to ride on the campus shuttles alongside their CSULB student parent/caregiver
- Teamed up with IPCDC to advertise events and create future events with one another
- On November 14<sup>th</sup>, there will be the event for a family friendly Zumba exercise class
- Began the student study hours at the Family Friendly Study Center in the Library (this is where parents can take their children into the library with them and have certified students who have volunteered help watch their children while they study)
- Worked with Jeff Klaus to submit a form that will allow a Family/Pregnant Parent Student resource center to be considered if a space opens up on campus

#### Goals for the Next 2 Weeks:

- Planning and scheduling upcoming events for the spring semester. One being a family socializing event at the bowling alley and the other being a family friendly movie night to see Frozen 2
- Updating the website for Pregnant and Parent students to be up to date and be easier to navigate.
- Creating consistent exercise classes that are child friendly at the rec. center and a waiver that allows children to go into the recreation center with their parent/caregiver.
- Meeting to ensure the continuation of the parent and child supported study session in the library for the upcoming semester.

## **Student Concerns/Issues:**

- Lack of general understanding of their rights and the fact that they do not have one location they can go to
  get their questions answered. Currently pregnant and parent students are redirected all over campus to get
  their questions answered. The WGEC is the location supporting pregnant and parent students however, this
  location is one that some fathers fell uncomfortable going to. The lack of general information for their
  resources can be fixed by updating the pregnant and parent student website. The lack of an area to get
  questions answered and to be inclusive to all parents can be addressed by creating a Family resource center.
- Senate did create a resolution in 2018 to support and help aid in the creation of a Family Resource Center (Bill number 2018-28). I would like to get together with some of the senators to find ways we can support this and ensure it is continually being worked on.
- Interactions with counselors on campus have left pregnant and parent students feeling discouraged, unsupported and misunderstood. Some have been told they have to be "realistic" or "choose" between their families and school.
- Many students feel there is a negative stigmatism about being a parent student (specifically younger parent student) and are hoping to find ways to educate the campus on what being a parent student is like to fight against this.
- No support groups specifically set up for fathers (will be working on this in the upcoming month)
- Students who are not parents are often using the Family Friendly Study Center and they will take up large
  spots at the table. These students also make the parent/pregnant students feel uncomfortable when they
  bring their children with them. So although this space was created for pregnant/parent students they do not
  feel it is for them. They do not feel comfortable utilizing the space and bringing their children with them.

#### Did You Know?

- 4.8 million Undergraduate students are raising dependent children.
- Of the total student parent population: 71% Women (3.4 million), 29% Men (1.4 million).
- 43% parenting students are single mothers (2 million); 11% are single fathers (533,000).
- 32% of college women are raising dependent children.
- 13% of students are single parents.
- Almost 5% of students have a child under the age of 1.

- 12% of students have at least 1 child under the age of 5
