  - The ASI funding allocation allows us to preserve a competitive DI athletics program by maintaining student-athlete scholarships, Cheer Team operations, and Pep Band operations.
  - Long Beach State continues to sponsor nineteen NCAA Division I intercollegiate sport teams (11 women's, 8 men's). All programs have remained consistent with no significant changes to participation numbers or budget allocation.
  - Athletics' vision is to cultivate leaders and champions and we do that by providing the best
    possible experience for our student-athletes in the classroom and on the field of competition,
    building and sustaining winning programs, and by doing things the "right way."

The Mission of Long Beach State University Intercollegiate Athletics is to cultivate Leaders & Champions. In the classroom. On the field of competition. In the community. Comprehensive excellence is our goal at 'the Beach'.

## Department of Athletics - Three Core Values:

- 1. Provide the best possible experience in the classroom and on the field of competition.
- 2. Build and sustain winning programs and compete for championships.
- 3. Always Do 'the right thing'.

## Role of the Spirit Team:

- The Spirit Team's role in our athletic departments has five main responsibilities: Crowd Leader, Spirit Raiser, Ambassador, Athlete and Entertainer. As Crowd Leaders, the spirit team is the connection between the fans and the athletic team. The energy and enthusiasm produced by the crowd can rally our sports teams to play better and boost overall morale. It is the spirit team's task to unify the crowd in its efforts.
- As crowd leaders, spirit leaders know the sports they are cheering for and understand how to choose an appropriate sideline chant. As a group, they begin sideline chants and also make organic chants from the crowd stronger by yelling the words in unison with fans. They preserve school traditions and come up with new ways to improve fan involvement.
- As Spirit Raisers, they promote and spread school pride throughout the year. Leading up to game day, they help with campus engagement with student-athletes, decorate hallways and doors with flyers and support the sports team playing that week. They encourage fellow students to show their spirit by setting a good example of Beach Pride themselves. On game day, their responsibility as spirit raisers is more emphatic. When a goal is scored or a basket is made, they display their enthusiasm by waving poms, yelling and celebrating. If spirit is low, they use tactics to increase excitement, including starting a sideline chant, and executing stunts, jumps, tumbling or pyramids (where permissible).
- As Ambassadors, the spirit teams are implored to be model students, both in and out of the classroom. Minimum GPA standards emphasize the importance of classroom performance. Many spirit team members are involved in other campus activities and programs and leadership positions and/or hold a part-time job. With service projects and community appearances, they become the recognizable faces of our university. This year they attended the Long Beach Marathon and cheered on runners passing though campus. They brought toys to the annual Stuff- A- Bus toy drive for the community and made care baskets for a local women's shelter.

Incorporating the Spirit Team to Athletics

- Just as we hold our student —athletes to a standard that far precedes what is happening on the playing field or court, it's preparing them with skills necessary for life after college. This includes: Character Development, Academics, Excellence and Community.
- Character Development Character development flourishes when coaches teach their athletes more than just the sports or activities in which they are participating. Well-rounded student-athletes look to their coaches and peers for examples on how to act and respond in tough situations. Good sportsmanship is one behavior that directly involves our spirit team on the sidelines. As crowd leaders during sporting events, they set a visible example to fans, students and athletes. If there is an injury, they take a knee. If there is a questionable call from a referee, they encourage the team to keep their chins up by starting a positive chant. They can also help squash inappropriate fan behavior. Their outward display of respect during games epitomizes character development.
- Academics The most important element of being an athlete is being a student first. School spirit weaves through all aspects of school, including the classroom. Even during class, they can continue to motivate others and set a good example.
- Excellence -Excellence in athletics covers everything from learning new skills to bringing home a
  victory. As crowd leaders and spirit raisers, the spirit team is the team behind the team. They
  root for individual players, entire sports teams and athletic departments. They know and
  understand that school spirit is a driving force that can motivate a team to play the best game
  possible. During games, a sports team's goal is to perform its best, and our spirit team is a piece
  of that puzzle.
- Community Athletics can bring a community together physically and emotionally. Our athletic department is committed to filling seats at games because it is a key component for an energized atmosphere, this can sometimes be a difficult task. As ambassadors for the university and representatives of student-athletes, they rally students, alumni and community members to attend games. When the spirit team engages with the campus community and city of Long Beach they connect students to the game and players by physically interacting with them. Positive experiences turn reluctant students into engaged fans, and engaged fans can influence others to attend games and we all win!
