Williams: requested using "can consider" instead of "may" in the Resolved clause

Williams: reviewed the following revisions in their edited version that wasn't included in the agenda packet:

- language is approved, as CSU falls under the category of all executive departments or agencies, as specified in the official definition
- changed any language that said adoption endorses because we wanted to make sure we wouldn't run into any legal issues
- changed "ASI" to "ASI Senate"
- remove the word "condemned" but it appears to be readded

Almahdi: the word "condemned" aligns with first amendment rights.

Bose: recommended changing the language "hate incident".

9. REPORTS

- A. Information Item: Lizbeth Velasquez, ASI President
 - There are CSU system wide conversations regarding credit/no credit for classes
 - Chancellor's Office sent out an email to the respective stakeholders outlining the guidelines for doing such and changing the declaration time for students to choose credit/no credit. We will be connecting with our AS to see what our individual plan will be for the campus
 - Beach Scholarships are moving forward, as the committee can review them from home
 - CSSA has announced the new ED Jeanne Tran-Martin who currently serves as the Director of Government Relations and Advocacy at CSUF; Tran-Martin will begin May 4th
 - Enrollment services has changed withdrawing from classes and you no longer need prior approval from the professor, chair or dean; email completed form to ES-registration@csulb.edu

Dr. Bose: The no-signature from professor, chair, or dean is temporary during this time of health concerns, it is not a permanent change.

- B. Information Item: Dr. Miles Nevin, ASI Executive Director
 - Thanked everyone for their continued patience
 - Spoke last week about the impending concerns for academics and refunds for fees, tuition, etc.; the economic impact on ASI is significant; doing alternate planning for the next term
 - This week we processed refunds for around 100 travel plans; we cannot refund tuition; don't know what future looks like
 - Commercial stores sales: revenue loss of a couple of hundred thousand dollars
 - As the largest on-campus employer, ASI will extend paying student staff as long as possible, until April 30th, which will cost \$300,000 dollars per month
 - BOC will review the ASI/USU consolidated operating budget (1st reading) on April 8th
 - ASI Management team is meeting weekly; some staff are coming in to ensure the organization's function

10. CLOSING COMMENTS

Ortiz: regarding the operating budget, do we have any idea how that might affect future scholarships for the senators, commissioners, chief officers, etc.?

Nevin: cannot anticipate anything yet but that shouldn't be an area where we cut our budgets; will cut from other areas first.

Ortiz: will cultural organizations funding be affected?

Nevin: that shouldn't be affected because those are our top areas; there should not be any impacts in ASI Government related operations.

Bose:

- Division of Student Affairs: many of our staff are on campus to keep operations going; things are transitioning, so please check website for updates
- Student Health Services and CAPS: there are some on-campus services available and some services are telephonic
- Working on creating a live Google Doc which will list all the resources that you received via email
- Available to address any questions and concerns

Deng: would students still have a "W" on their transcript if they withdraw at this point?

Dr. Bose: yes, we cannot change a transcript, as it is against the law; will count on their limit for withdrawals.

Deng: regarding the extended pay for ASI student employees, does it include the SRWC? Nevin: yes, all temporary ASI student employees will be paid until April 30th.

Deng: there was a \$11 million donation when the CSUBOT approved the Student Success Center's name change; has there been any discussion regarding what we'll receive for Basic Needs and/or the Beach Pantry? Also, funds donated might be better utilized by ensuring students have food during this time while they are home.

Nevin: That donation was a big help for Basic Needs and the Beach Pantry; the next Beach Pantry popup is tentatively scheduled for Friday; conversations with donors for long-term Beach Pantry support are pending; Basic Needs continues to be a priority.

Deng: a; voiced concern that campus administrators haven't stepped in on a recent incident of a student posting discriminatory jokes about their fellow classmates on social media.

Bose: offered the option of a restorative circle, led by Dr. Bryant, to willing parties; as the university operating more online, suggested ASI think about how to best serve students in a virtual way; offered their assistance on anyone willing to work on a campaign.

Hafen: Chair of Academic Senate received information that credit/no credit may be implemented this semester; Academic Senate there will be discussing this at their next meeting tomorrow; encouraged senators to stay in touch with their dean regarding current college/campus information and concerns.

Triska: suggested a Beach Pantry donation drive; questioned whether the budget allocated to CSU's might change due to the corona virus.

Nevin: made note of donation drive; keep an eye on social media mediums, as their impact is very significant; heard that the governor's budget is changing but is not sure what to expect.

Williams: voiced appreciation for receiving a Beach Pantry box last week.

Nevin: Beach Pantry and Basic Needs has given out electronic credits, Grub Hub coupons, etc.; to minimize contact between individuals, as much as possible.

Triska: suggested publicizing the opportunity for people to donate towards gift cards.

Sajjan: voiced concern towards their ASI Scholarship eligibility in that they are only carrying 4 units in their last semester, and the scholarship department said they needed to be enrolled in minimum of 8 units.

Bose: encouraged use of resources that they shared last week.

Almahdi: deadline for agenda items, including resolutions, is Thursday, 10pm; deadline is important, as everyone is working remotely; encouraged everyone to take care.
