- A. Legislative Business
 - Action Item: SR #2022-03 Support of California State Legislature Bills of Interest (2nd Reading) <u>SB641 - CalFresh for College Students Act</u>
 - Stance: Support

This bill would require the State Department of Social Services to post on its internet website updated program lists and instructions to counties, and would require the instructions to include specific guidance for processing applications, reporting, and recertification for additional students who are exempt from the CalFresh student eligibility rule. The bill would require the department to convene a workgroup to identify the steps necessary to establish a CalFresh application submission process that improves access to real-time information about applications submitted and accommodates the large influx of CalFresh applications during the beginning of a school term, as specified.

AB1602 - California Student Housing Revolving Loan Fund Act of 2022

• Stance: Support

This bill would establish the California Student Housing Revolving Loan Fund Act of 2022 to provide zero-interest loans to qualifying institutional applicants of the University of California, the California State University, and the California Community Colleges for the purpose of constructing affordable student housing and faculty and staff housing. The bill would establish the California Student Housing Revolving Fund as a continuously appropriated fund in the State Treasury, thereby making an appropriation. The bill would state the intent of the Legislature to appropriate \$5,000,000,000 for purposes of the housing loans.

AB1671 - California Ban on Scholarship Displacement for Foster Youth Act of 2022

• Stance: Support

Commencing with the 2023–24 academic year, an institution of higher education shall not reduce a student's institutional financial aid offer or award for an academic year as a result of private scholarship awards received by that student unless all of the following conditions are satisfied:

- The student is ineligible to receive a Federal Pell Grant award
- > The student is ineligible to receive financial assistance under the California Dream Act
- > The student's gift aid exceeds the student's financial need
- > The institution reduces its institutional financial aid by no more than the amount of the student's gift aid that is in excess of the student's financial need.
- > The institution does not consider a student's receipt or anticipated receipt of a private scholarship when considering a student's qualification for institutional financial aid.

SB929 - Community Mental Health Services data collection

• Stance: Support

Would require the State Department of Health Care Services to collect and publish data regarding clinical outcomes for individuals placed in each type of mental health hold, services provided in each category, waiting periods, and needs for treatment beds.

AB595 - Public Postsecondary Education- University of California and California State University: student eligibility policy

• Stance: Support

This bill would require the CSU Board of Trustees to engage in open public discussions with other education; segments that would be impacted before making changes to the eligibility requirements for undergraduate students. The bill would also require the trustees to commission an independent study by a third-party research organization to assess the impact of the proposed change in student eligibility policy on the eligibility rates of the graduates of public secondary schools who are members of underrepresented student groups, and specifically examine the impact on eligibility and admission rates of all high school graduates, disaggregated by race, ethnicity, income, and region.

AB295 - Public postsecondary education: pilot program for free cost of attendance: working group

• Stance: Support

This bill would establish a working group with representatives from the State Department of Education, UC, CSU, and CC system to evaluate the creation of a pilot program that would cover the cost of attendance at post-secondary education in the state by replacing the system of charging students fees and tuition for or enrollment at a public postsecondary institution.

AB1232 - Community colleges: nonresident tuition fees: English as a second language courses

• Stance: Support

Non-California residents pay a higher tuition fee compared to CA residents in the CCC system. This bill would exempt this "non-resident" tuition fee for students who are enrolled in an English Second Language college course and who are:

- A recent immigrant, as defined in Section 1101(a)(15) of Title 8 of the United States Code (USC);
- A recent refugee, as defined in Section 1101(a)(42) of Title 8 of the USC; and,
- A person who has been granted asylum by the United States, as defined in Section 1158 of Title 8 of the USC.
- > The student must have been living in CA for less than 6 months

AB1764 - Public postsecondary education: student housing: survey

• Stance: Support

This bill would require the Office of the Chancellor of the California State University, the Office of the Chancellor of the California Community Colleges, and the Office of the President of the University of California to collect data on student housing insecurity at each of their respective campuses, as specified. The collected data can be used to improve state policy discussions on student housing, to identify campuses and segments with the greatest barriers to student housing, and to prioritize future state funding designated for student housing. The collected data shall include all of the following information:

- The percentage of enrolled students who currently receive affordable housing and are considered part of a special needs population
- The percentage of students who live off campus and on campus, who are first-generation college students and students who are current or former foster youth

AB-2371 Public postsecondary education: California State University: tuition

• Stance: Support

This bill would prohibit the charging of tuition or mandatory system wide fees for enrollment at a campus of the California State University for any academic year, for up to 2 academic years, to a California Community College resident transfer student who has completed an associate degree for transfer and has received a fee waiver, as provided. Upon the enactment of an appropriation for this purpose, the bill would require the Chancellor of the California State University to distribute funding to each California State University campus to offset the costs of waiving tuition and mandatory system wide fees to transfer students pursuant to this bill.

National Data Points

- 53% of students were worried/scared often or constantly in the past 6 months
- 59% of students turn to parents, family, or extended family for help first
- 65% of students rate their behavioral health as fair or poor
- 75% of faculty members nationally are willing to help students in distress, but only 50% of those know how
- Disparities for first gen, low-income students of color are NOT in their symptoms but largely in their help-seeking behaviors.

CSULB Data Points

- 27% reported a death of a family member, loved one or friend due to COVID-19
- 39% of our students have accessed the Enrollment Services chat bot for help between 5 p.m.-8 a.m.
- 57% reported witnessing online or in-person discriminatory or hostile exchanges due to someone's race/ethnicity
- 85% of our campus mental health services require a student to initiate an action (make an appointment, visit a site, go to a program or group)
- 86% reported moderate or high stress in the last 12 months

Objective #1

We will honor our students' diversity by using culturally informed practices and developing strategies to promote inclusive excellence in services

- 1) Ensure professional staff and peer mentors in our behavioral health units have demonstrated skill and commitment to serving diverse student populations using culturally informed and trauma informed approaches

AB 295 (Jones-Sawyer) Public Postsecondary Education: Pilot Program for Free Cost of Attendance: 62

63 Working Group

64 This bill would establish a working group with representatives from the State Department of Education,

- UC, CSU, and CC system to evaluate the creation of a pilot program that would cover the cost of 65 attendance at post-secondary education in the state by replacing the system of charging students fees

AB 595 (Medina) Public Postsecondary Education- University of California and California State 69 70 **University: Student Eligibility Policy**

88 AB 1602 (McCarty) Student Housing Revolving Loan Fund Act of 2022

The bill would require the department to convene a workgroup to identify the steps necessary to establish a CalFresh application submission process that improves access to real-time information about applications submitted and accommodates the large influx of CalFresh applications during the beginning of a school term, as specified.

With the current disturbances that have followed from the war, it is more than evident that 46 students, staff, and faculty feel deeply affected by the tragedies, violence, acts of war, and threats being 47 sent worldwide by the Russian President, Vladimir Putin who has put Russia on high alert which includes 48 nuclear force and military deterrence; and 49 50 the combined number of civilian and military casualties in Ukraine during Russia's WHEREAS 51 invasion has reached over 352, of which, 14 are children, and the number of wounded is over 1,684 of 52 which, 116 are children⁴; and 53 54 WHEREAS the highly dangerous Russian troops immorally invaded the borders of Ukraine, a recognized sovereign state; and according to the United Nations (UN) more than 800,000 civilians have 55 56 fled Ukraine, and the European Union (EU) estimates at least four million people will attempt to leave the country⁵; and 57 58 59 WHEREAS the combined number of 1,004,713 refugees have sought refuge in Poland, Hungary, Moldova, Slovakia, Romania, Russia, and Belarus⁶; and 60 61 62 WHEREAS the United Nations General Assembly passed a resolution calling Russia to stop the war⁷; 63 and attempts of diplomacy and peace have been rejected by the Russian Federation as they continue 64 their attacks in crowded urban areas; and therefore, be it 65 66 RESOLVED that CSULB ASI stands in solidarity with our Ukrainian students and our Student Service 67 Members that may be affected by the ongoing situation; and 68 69 RESOLVED that ASI recognizes the various resources offered at CSULB and will ensure that targeted 70 communities are provided with information and resources regarding these services available to them; 71 and be it further 72 73 RESOLVED that ASI will continue to fulfill its duty to represent CSULB students, faculty and staff, 74 acting and advocating on their behalf by strongly condemning further the violence that Russia is inflicting 75 upon Ukraine and the Russian Federation; and 76 77 RESOLVED that ASI will continue to stand in solidarity with the CSULB student body and members of 78 our community, and will not tolerate hatred, bigotry, or violence- anywhere; and be it finally 79
