WHEREAS the Associated Students, Inc. (ASI) Board of Directors at California State University, Long

Beach (CSULB) is the recognized voice for over 37,000 students; and

WHEREAS CSULB has recently received the Active Minds Healthy Campus Award<sup>1</sup> and has adopted

a sustainability initiative, which includes water use and waste reduction; and

WHEREAS hydration stations were installed on this campus in 2010 to help alleviate student thirst

and increase sustainability, and only requires maintenance checks about every 3,000

gallons of water used<sup>2</sup>; and

WHEREAS hydration stations on campus have helped eliminate waste from disposable water

bottles of up to 224,000 16-ounce water bottles, and have propagated the use of

reusable water bottles; and

WHEREAS every square mile of the ocean has at least 46,000 pieces of floating plastic in it,3 and

polluted beaches are a prominent issue in our community; and

WHEREAS the average person requires about 100 ounces of water a day, and in the absence of this

amount can result in a decrease of clarity, and an increase in fatigue, emotional

instability, stress, and sleep issues, which would be detrimental to student success;<sup>4</sup> and

WHEREAS hydration stations provide students with filtered water, which is cleaner than bottled

water<sup>5</sup> and can effectively reduce the risk of contamination and balance the pH of

water;6 and

### WHEREAS

certain campus locations are lacking updated hydration stations or access to hydration stations in general including:

- Dance Center
- Carpenter Performing Arts Center
- Engineering buildings (Engineering 2,3,4, Engineering & Computer Sciences, Engineering Technology and Vivian Engineering Center)
- Fine Art buildings
- Social Sciences/Public Administration (SSPA)
- University Theatre
- Human Services and Design building
- Nursing and Family and Consumer Sciences buildings
- Science buildings (Hall of Science, Microbiology, Molecular and Life Sciences Center);<sup>8</sup> now therefore, be it

### RESOLVED

that CSULB ASI urges Physical Planning and Facilities Management to increase the number of filtered hydration stations by replacing old water fountains with hydration stations and updating all of the current hydration stations on campus; and be it further

#### RESOLVED

that CSULB ASI supports the implementation of campus-wide hydration stations in every building on campus within the next three years; and be it finally
