Title: In Opposition to the Potential 2017-2018 CSU Tuition Increase

WHEREAS the Associated Students (ASI) Board of Directors of California State University, Long

Beach (CSULB) is the recognized voice for over 37,000 students; and

WHEREAS the CSU Board of Trustees (CSU BOT) is responsible for the oversight and adopts rules,

regulations, and policies which govern the California State University; and

WHEREAS on September 29, 2016, CSU Chancellor Timothy White issued a letter to the California

State Student Association (CSSA) President David Lopez and Chair of the Board of Directors Isabelle Franz entailing a possible 2017-18 Tuition Proposal for Consideration;

and

WHEREAS CSSA has failed to develop a strategic plan to combat the possible tuition increase, and

has failed in providing support for the individual CSU campuses; and

WHEREAS in this document the Office of the Chancellor states the priorities of the CSU are:

Graduation Initiative 2025, Enrollment Growth, Infrastructure, Employee Compensation,

and Mandatory Costs; most of the latter two regarding the increase of California

minimum wage and raise for California faculty and staff<sup>2</sup>; and

WHEREAS the Preliminary CSU 2017-18 Budget Plan calls for a \$364 million budget to cover the

priorities mentioned above; and

WHEREAS the anticipated revenue contains \$157.2M from the Administration's Anticipated

Funding Plan and \$20M in anticipated revenue from tuition from enrollment growth,

which totals \$177.2M in anticipated revenue for the CSU system;<sup>3</sup> and

WHEREAS this leaves the CSU system with a remaining need of \$168.8M, to which the CSU Office

of the Chancellor proposes raising tuition to compensate for that gap;<sup>4</sup> and

WHEREAS the proposed tuition increase for California State University students taking more than

six units is \$270 per year for undergraduates programs, \$312 per year for credential

programs, \$438 per year for graduate and other post-baccalaureate programs; and

WHEREAS	the potential annual tuition increase for the Doctor of Education program is \$720, and the Doctor of Nursing Practice is \$930, and the Doctor of Physical Therapy is \$1,048; and
WHEREAS	the proposed tuition increase for non-resident tuition per semester unit rate is \$24, which would increase a FTES (Full Time Equivalent Student) by \$360, so \$720 a year; and
WHEREAS	49% of the students who graduate from the CSU will accumulate loan debt for college related expenses; 7 now therefore, be it
RESOLVED	that with an adoption of this resolution, the CSULB ASI Board of Directors officially opposes any possible tuition increase for CSU students and the suggested possible increases in the CSU BOT proposed document; and be it further
RESOLVED	that the CSULB ASI Board of Directors stand in solidarity with the CSULB student body, including all CSULB student leaders, and the CSU independent organizations such as Students for Quality Education, in mobilizing and advocating for the current needs of the diverse CSU student body; and be it further
RESOLVED	that CSU students should not be held fiscally responsible for the economic impact made by decisions of the state legislature such as the raise in minimum wage and increase in compensation for California State University faculty and staff; and be it further
RESOLVED	that the CSULB ASI Board of Directors requests the CSU BOT to reevaluate its priorities for the CSU system to better reflect the current needs of the diverse CSU student body; and be it further
RESOLVED	that the CSULB ASI Board of Directors urges that the CSU BOT stand in solidarity with CSU students in advocating to Governor Jerry Brown and the California State Legislature with the intention to fully fund the needs of the CSU students; and be it further
RESOLVED	that the CSULB ASI Board of Directors support the efforts of the other 22 CSU's in their efforts on advocating against the potential tuition increase; and be it finally
