WHEREAS the Associated Students, Inc. (ASI) Senate of California State University, Long Beach (CSULB) is

the recognized voice for over 37,000 students; and

WHEREAS the Chapter II AS Bylaws state that each individual Senator must, "Serve the best interests of the

corporation and its shareholders, and avoid any conflicts of interest;" and

WHEREAS to serve the "best interests of the of the corporation and its shareholders" may require the

removal of a Board of Director from office if they are not completing their duties; and

WHEREAS there are currently no specifics within the bylaws on removing a Senate elected Board of

Director; and

WHEREAS to serve the "best interests" the Senate may need to remove an Officer from their position for

the prosperity and success of the organization in its mission; and

WHEREAS the Senate elects many positions within ASI student government such as IPCDC Trustees-at-

Large, Lobby Corps Students-at-Large, ASI Media Board Trustees-at-Large, Public Defender,

Government Elections Officer, Academic Senators; now therefore, be it

RESOLVED that the CSULB ASI Senate Bylaws be amended to add the following duties in Chapter II, Article I,

Section I. K to state the following:

"K. Remove any officer elected by the Senate if they are not completing and fulfilling their duties specified by their positions.

I. The removal process will goes as follows:

"The Vice President, the President, or the Chair of the Officer in question may submit a petition of charges to remove a student from office. If the Officer in question is a Chair of a Board, the highest ranking Officer of said Board would be the student who could submit the petition of charges. The signed petition containing the charges must be submitted to the President, Vice President, the Chair of the Officer in question or the highest ranking Officer, and the Officer being charged in both written and electronic form.

Within two weeks of receipt of the petition, the Vice President must hold a special meeting wherein the Senate will act as a court. In which the removal will be considered an Action Item under Executive Business. To start, the person submitting the petition will have 10 minutes to speak. Then the Officer in question will have 10 minutes to speak. After, the court discussion will follow the specifications made in the Senate Working Rules for that year. The Vice President or Vice President Pro-Tempore will preside. If 2/3 of the entire Senate finds the Officer guilty, the said Officer will be removed from Office.

II. The Officer removed can file an appeal through the Judiciary branch;" and be it further
