WHEREAS the Chapter One CSULB AS Bylaws states the Senate is to, "Perform any and all duties imposed

on them collectively or individually by the Senate, by law, by the Articles of Incorporation for the

Associated Students, California State University, Long Beach, or by these bylaws;" and

WHEREAS these duties include changing the AS Bylaws in order to create the most beneficial system to

support students; and

WHEREAS in spring 2016, the 2015-2016 ASI Senate approved a reorganization structure to make ASI more

beneficial to the student body; and

WHEREAS since spring 2016, there have been various edits to this proposal in order to increase the

efficiency of ASI Student Government; and

WHEREAS as a result of the reorganization the position of Chief Academic Officer will be created to ensure

that the duties previously assigned to the Secretary for Academic Affairs continue to be fulfilled;

and

WHEREAS as a result of the reorganization the position of Chief Government Relations Officer will be

created to ensure that the duties of the Secretary for City Affairs and Secretary for System-Wide

Affairs continue to be fulfilled; now therefore, be it

RESOLVED that the Press Secretary, Secretary for Government Recruitment, Secretary for Academic Affairs,

Secretary for Internal Affairs, Secretary for City Affairs, and Secretary for System-Wide Affairs be

removed from the AS Bylaws; and be it further

RESOLVED that the position Commissioner for Wellness Affairs, be created: Chapter II, Section 2.B.3

"The Commissioner for Wellness Affairs promotes the cohesion and awareness of the variety of wellness positions in order to ensure that holistic mental, physical, spiritual, emotional, and psychological wellness remains at the forefront of the university's goals;" and be it further

RESOLVED that any reference to the "Chief of Staff" be changed to the Chief Diversity Officer; and be it

further

RESOLVED that the Commissioner for Sustainability be changed to Commissioner for Environmental Justice;

and be it further

RESOLVED that the Commissioner for Cultural Diversity be changed to Commissioner for Cultural Affairs;

and be it further

RESOLVED that the title of "Secretary" be changed to "Commissioner" throughout the entire AS Bylaws in

regards to the Presidential Cabinet; and be it further

RESOLVED that this resolution allows the ASI Vice President the authority to change the AS Bylaws to

reflect the aforementioned changes; and be it finally
