WHEREAS	the Associated Students, Incorporated (ASI) Board of Directors at California State University, Long Beach (CSULB) is the recognized voice for over 37,000 students; and
WHEREAS	the AS Bylaws Chapter II Article I, Section 17 lists the officers of the Associated Students; ¹ and
WHEREAS	there are many subcommittees of the Senate including Lobby Corps, Senate Audit Committee, and Social Justice and Equity Committee (SJEC); ² and
WHEREAS	that the Chapter II Article VI, Section 17 states that, "The Social Justice and Equity Committee will act as a liaison on behalf of the Associated Students, Incorporated on matters of social justice issues;" ³ and
WHEREAS	that the intent behind creating SJEC was to have a board serve as a liaison between student organizations and the university when campus climate issue arose; ⁴ and
WHEREAS	that over the past three years it has been challenging for the board to develop goals that are not a duplication of Cabinet's role or Senate as far as policy making; and
WHEREAS	that the Cabinet was restructured in spring 2017 to have a more social justice focus, so SJEC has become a duplication of Cabinet; ⁵ and
WHEREAS	that the structure of SJEC has served as a limitation of the board and has served as a barrier to progress; now therefore, be it
RESOLVED	that SJEC will be taken out of the Chapter II Bylaws and be incorporated into the Senate working rules with the following language:
	 The Social Justice and Equity Ad-Hoc Committee: A. Scope The Social Justice and Equity Ad- Hoc Committee will act as a liaison on behalf of the Associated Students, Incorporated on matters of social justice issues. B. Membership The Social Justice and Equity Ad-Hoc Committee will consist of the following voting members: 1. One Senate Representative elected by the Senate 2. Unlimited Students-at-Large 3. One Faculty Representative appointed by the Academic Senate

- C. Chair

The Chair shall be the Chief Diversity Officer.

- D. Rules and Procedures The Social Justice and Equity Ad-Hoc Committee will provide for its own rules and procedures
- E. Duties and Powers

The Social Justice and Equity Ad-Hoc Committee will:

- 1. Meet at least twice per academic year to discuss campus climate issues regarding underrepresented communities on campus.
- 2. Meet additionally, as needed, when incidents occur on campus.
- 3. Discuss and advocate for social justice issues in collaboration with the Senate.
- 4. Serves as a board in which students can voice their concerns regarding campus climate and social justice issues.
- 5. Develop a plan of action, programs and policies that advance social justice and equity on campus as issues arise.
- F. Meetings

SJEC will meet at least once a semester at a time and location that the majority of the board membership sees most appropriate; and be it further

- **RESOLVED** that CSULB ASI Senate and all ASI boards are still dedicated to advancing social justice on our campus and community altogether; and be it further
- **RESOLVED** that this resolution allows the Vice President the authority to reflect current changes of this resolution throughout the AS Bylaws; and be it finally
- **RESOLVED** that an electronic copy of this resolution, upon approval by the ASI President be distributed to CSULB President Jane Conoley, Interim Vice President for Student Affairs Mary Ann Takemoto, Dean of Students Piya Bose, all current and future ASI Officers, the Daily 49er and 22 West Media.
