WHEREAS the Associated Students, Incorporated (ASI) Board of Directors at California State University,

Long Beach (CSULB) is the recognized voice for over 37,000 students; and

WHEREAS the AS Bylaws Chapter II Article II, Section 3 lists the executive officers of the Associated

Students;¹and

WHEREAS the ASI reorganization in 2016 created three Chief positions: Chief Academic Officer, Chief

Diversity Officer, and Chief Government Relations Officer;² and

WHEREAS that the Chief Academic Officer was created from the Secretary for Academic Affairs position,

following the reorganization of the President's Cabinet with a focus on social justice and equity;³

and

WHEREAS that the student leader with academic affairs purview is an important position and one that can

most efficiently and effectively function as an Academic Affairs Officer, similar to how it

functioned historically; and

WHEREAS that two years ago, there was a creation of an automated committee reporting system that has

been fully implemented this year; and

WHEREAS that the implementation of the automated committee reporting system has dramatically

reduced the required workload of the Chief Academic Officer position; and

WHEREAS that the Chief Academic Officer's workload can be sufficiently completed within the framework

of an officer position description, as opposed to a chief position, and will still report to the ASI

President; and

WHEREAS that the Chief Diversity Officer and Chief Government Relations Officer positions have oversight

over board members which merit a chief role; however, the Chief Academic Officer position

does not oversee a board or have direct reports; now therefore, be it

RESOLVED that Chapter II Article II, Section 3 replace the Chief Academic Officer with Academic Affairs

Officer; and be it further

RESOLVED that this position will no longer be regarded as a chief position; and be it further

RESOLVED that this resolution allows the Vice President the authority to reflect current changes of this

resolution throughout the AS Bylaws; and be it finally
