**Title:** Bylaw Amendment to Lobby Corps Membership

**WHEREAS** the Associated Students, Incorporated (ASI) Board of Directors at California State University, Long Beach (CSULB) is the recognized voice for over 37,000 students; and

**WHEREAS** the AS Bylaws Chapter II Article I, Section 16 list the members of Lobby Corps;<sup>1</sup> and

**WHEREAS** the ASI Vice President currently sits on Lobby Corps; however, since the ASI President is the alternate voting member on the Cal State Student Association (CSSA) Board of Directors, which Lobby Corps works closely with, it is more appropriate for the President to serve on this board; now therefore, be it

**RESOLVED** the Chapter II of the AS Bylaws will be edited to reflect the following change:  
Article I, Section 16 Membership:

The Lobby Corps Committee will consist of the following voting members:

1. Three (3) Senators elected by the Senate
2. Three (3) students-at-large will be elected at the start of the academic year (June 1st – May 31st) by the Senate. Any board vacancy throughout the year will be filled through a recommendation by the Committee and elected by the Senate. Each student-at-large will have with each having a primary focus on
  - a. Long Beach City Council
  - b. CSU Board of Trustees
  - c. District Visits
3. ASI President or designee
4. Associate Vice President, University Relations
5. ASI Chief Government Relations Officer, who will serve as Chair

Lobby Corps Committee will consist of the following non-voting members:

1. Executive Director or designee
2. Student Advocates; and be it further

**RESOLVED** that this resolution allow the Vice President the authority to reflect current changes of this resolution throughout the AS Bylaws; and be it finally

**RESOLVED** that an electronic copy of this resolution, upon approval by the ASI President be distributed to CSULB President Jane Conoley, Vice President for Student Affairs Beth Lesen, Provost Brian Jersky, Dean of Students Piya Bose, all current ASI Officers, the Daily 49er, and 22 West Media.
