WHEREAS the Associated Students, Incorporated (ASI) Board of Directors at California State University, Long Beach (CSULB) is the recognized voice for over 37,000 students; and

WHEREAS the AS Bylaws Chapter II, Article II, Section 2B lists the officers of the Associated Students Presidential Cabinet Commissioner roles;¹ and

WHEREAS the current Commissioner for LGBTIQ+ Affairs position title and responsibilities are listed as follows:

4. Commissioner for Lesbian, Gay, Bisexual, Transgender, Intersexual and Queer+ Affairs (LGBTIQ+)
The Commissioner for LGBTIQ+ Affairs is responsible for promoting awareness and appreciation of students who are Lesbian, Gay, Bisexual, Transgender, Intersexual, and Queer (LGBTIQ+) in order to foster a multicultural and safe educational environment on behalf of the President; and

WHEREAS in an effort to ensure that ASI is moving towards a more inclusive environment the Commissioner for LGBTIQ+ Affairs title and responsibilities, be reevaluated; now therefore, be it

RESOLVED that Chapter II, Article II, Section 2B4 be edited to reflect the following changes:

4. Commissioner for Lesbian, Gay, Bisexual, Transgender, Queer, Intersex, Asexual+ (LGBTQIA+) Affairs
The Commissioner for LGBTQIA+ Affairs is responsible for advocating for resources and awareness for students who are part of the LGBTQIA+ community in order to strengthen an intersectional and safe educational environment on behalf of the President; and be it further

RESOLVED that this resolution allows the Vice President the authority to reflect current changes of this resolution throughout the AS Bylaws; and be it finally

RESOLVED that an electronic copy of this resolution, upon approval by the ASI President be distributed to CSULB President Jane Conoley, Vice President for Student Affairs Beth Lesen, Dean of Students Piya Bose, all current and future ASI Officers, the Daily 49er and 22 West Media.
